**SUBJECT:** **Tax Relief for Non-Profit Organizations: Proposed Renewal of Tax Relief and Additions for Fiscal Year 2015-16**

---

### **ORIGIN**

Pursuant to HRM Administrative Order 2014-001-ADM application must be made annually to confirm eligibility for renewal of tax relief. An open call for applications is advertised annually for consideration in the following fiscal year, subject to eligibility and the program's budget capacity.

### **LEGISLATIVE AUTHORITY**

*HRM Charter* (2008) s. 79 (1) (av) respecting discretionary grants and contributions and 79(2) requires that the Municipality publicize all grants and contributions made pursuant to 79(1)(av) in a newspaper circulating in the region.

*HRM Charter* (2008) s. 71(2) the Municipality may not grant a tax concession or other form of direct financial assistance to a business or industry.

*Administrative Order 2014-001-ADM Respecting Tax Relief to Non-Profit Organizations.*

### **RECOMMENDATIONS**

It is recommended that the Grants Committee approve in principle:

1. the renewal of tax relief for 626 properties as listed in Schedules 26 to 30 of this report, including an increase in tax relief for four (4) properties as shown in Table 2, effective April 1, 2015 unless stated otherwise, at an estimated combined cost of \$3,044,426 from Account M311-8006;
2. tax relief for 13 properties in Table 3 (Leases to be renewed), effective April 1, 2015 unless stated otherwise, at an estimated combined cost of \$129,766 from Account M311-8006;
3. pro-rated tax relief for the Kinsmen Club of Dartmouth, 30 Caledonia Road, Dartmouth, Dartmouth Non-Profit Housing Society, 357 Portland Street, Dartmouth and Creighton/Gerrish Development

Association, 2256 Gottingen Street, Halifax from Account M311-8006 at a combined cost of \$9,575;

4. the addition of 39 properties as listed in Table 4 of this report, effective April 1, 2015, unless stated otherwise, at an estimated combined cost of \$124,236 from Account M311-8006;
5. that all tax relief awards are conditional upon payment of any debt to the Municipality and/or pro-rated for default or any change in ownership or tenancy occurring within fiscal year 2015.

## **BACKGROUND**

Presently, HRM provides tax relief to non-profit and charitable organizations under the authority of s.79 (1) (av) of the *HRM Charter* (2008) enacted through HRM's Administrative Order 2014-001-ADM. A review of the program has been undertaken through the Grants Committee but changes are required to the Halifax Charter in order to streamline the program, as well as clarify a number of technical issues.

The current levels of tax relief, referred to as "Schedules", and conventional terms and conditions of funding are included in **Attachment 1** of this report. Late applications may be denied. Late applications to renew a prior year award may be pro-rated to deduct one day of eligibility for each day late.

## **DISCUSSION**

### **I. Recommended Renewals**

**Renewal:** If approved, the combined cost of renewals in 2015 including any increase in tax relief is \$3,046,723: this value *excludes* additions in Table 4.

**Renewal with Increase:** The 2015 program received requests to increase the level of tax relief on thirty-eight (38) properties. Several of these applications are repeat requests previously declined by Council. A modest increase is recommended for four (4) supportive housing facilities shown below in Table 2. These properties are owned by registered Canadian charities and used directly and exclusively for a charitable purpose. If approved, the net combined increase in cost to the program is \$7,832.

The amount of tax paid after tax relief compares fairly with the average tax paid by a homeowner (\$2,515)<sup>1</sup> and the average tax paid by a lower income homeowner under the *Residential Tax Rebate Program* (\$1,051)<sup>2</sup>.

**Pro-rated Award for Property Removed from Program:** Pro-rated awards are recommended for three (3) properties due to the timing of sale or lease expiry. The Kinsmen Club of Dartmouth were removed in 2014 and shall receive 3 months tax relief (\$838), Dartmouth Non-Profit Housing Society sold 357 Portland Street, Dartmouth, May 22, 2015 (\$202), and Creighton-Gerrish Development Association sold 2256 Gottingen Street, Halifax, October 15, 2015 (\$8,535). The combined total cost is \$9,575.

**Table 3: Leases to be Renewed:** Administrative Order 2014-001-ADM limits tax relief to the property owner or those with long-term written leases. Several organizations previously accepted into the program are in long term leases with HRM which have not yet been formalized in writing. While they generally meet the spirit of the program they do not meet the technical requirements of the new Administrative Order. This failure to meet these requirements is the fault of both those organizations and HRM. As such, it is recommended that these properties be removed from the program's schedules but that for 2015-16 the tax relief continue to be funded through M311-8006 as per the schedules they would otherwise have been on..

**Pro-Rated Late Renewals:** To date, Council has not accepted revoking tax relief for late renewal applications. In the alternative, a pro-rated deduction of one day's eligibility for each day late avoids an abrupt "all-or-nothing" penalty while acknowledging that the vast majority of program participants abide by the program's policies. The aim of pro-rating is not to save money; it is a default prevention technique to encourage program participants' to self-manage.

In the 2015 program eight (8) organizations did not submit their renewal application by the stated deadline (November 30, 2014); these groups were notified in writing of an extension to March 1, 2015, Followed by a notice of intent to recommend a pro-rated deduction issued March 13, 2015<sup>3</sup>. The date upon which overdue applications will be received by HRM is unknown, therefore the full value of tax relief renewal has been included for budgeting purposes only (Table 1) and these awards noted as "conditional" in the applicable Schedule in Attachments 2, 5, and 6 of this report.

## II. Recommend Addition to the 2015-16 Program

It is recommended that 39 properties be added to the program at a combined total cost of \$124,236. These proposed additions are shown in the applicable Schedule in **bold type** to distinguish them from renewals.

Using 2015 assessment values the estimated cost of tax relief for Soccer Nova Scotia Training Centre Inc (\$333,134) and Feed Nova Scotia (\$5,000) is \$438,134.

### Schedule 26

#### **1.Feed Nova Scotia, 215-217 Bedford Highway, Bedford**

In 1998 HRM entered into a lease-to-own agreement with the Metro Food Bank Society (Feed Nova Scotia), a registered Canadian charity, for two properties located on the Bedford Highway. In 2007, the organization was added to the former HRM By-law T-200 as fully exempt. In error, only one of the properties (213 Bedford Highway) has been assessed as taxable. The owner has been notified and HRM has requested Property Valuation Services correct the tax roll for the 2016 fiscal year. Although \$0 tax is payable in 2015 the first tax bill in 2015 will precede any assistance provided under the tax relief program. In 2015, the assessed value of the property is \$292,000 but this value could increase with re-assessment. *It is recommended that Feed Nova Scotia, 215-217 Bedford Highway be added to Schedule 26, effective April 1, 2015, at an estimated cost of \$0 in fiscal year 2015.*

#### **2.Soccer Nova Scotia Training Centre Incorporated, 210 Thomas Raddall Drive, Halifax – Conditional: Excludes Commercial/Government Leases – Land Lease/HRM**

In 1998 HRM entered into a 35 year land lease agreement with Soccer Nova Scotia Training Centre Inc for the construction of a fieldhouse. In 1998, the property was added to Schedule 26 under former HRM By-law T-200. In error, the property was assessed Commercial Exempt and was removed from the program in 2014. Property Valuation Services has confirmed a tax account has been created for the 2016 municipal tax roll. The property's assessment value is \$12,902,400; at the Commercial rate taxes would be \$433,134. Reinstatement in 2015 is recommended because the first tax bill in 2016 will precede tax relief approval. Three (3) registered non-profit tenants are included under the facility owner's tax relief: Soccer Nova Scotia (#3022247), Nova Scotia Soccer League (#3023144), and Capital Inter-District Soccer Association (#2303930). A commercial lease and HRM's tenancy are excluded from tax relief pursuant to Section 6a and b of the Administrative Order. *It is recommended that Soccer Nova Scotia Training Centre Incorporated, 210 Thomas Raddall Drive, Halifax, be added to Schedule 26, effective April 1, 2015, excluding commercial and government leasing, at an estimated cost of \$0 in fiscal year 2015.*

### Schedule 28

#### **3. Fairview United Family Resource Centre, 6 Titus Street, Halifax**

Established in 1986, the Centre is a registered non-profit society and a Canadian charity that provides family support and educational programs for adults and children. The society is dependent upon operating grants from the Province of Nova Scotia and the federal government. In 2014, the society acquired property which is assessed as Commercial (\$5,103) and Residential (\$1,408). The former mixed-use building no longer has a rental apartment. Therefore, the assessment classification should be corrected to reflect the building's non-residential use. Full exemption requested. It is recommended that full exemption be declined. Partial exemption at 50% of the Residential tax rate is higher than recent additions to the program and the amount of tax paid by the Centre will be comparable to other family

resource centres<sup>4</sup>. *It is recommended that the Fairview United Family Centre, 6 Titus Street, Halifax, be added to Schedule 28, effective April 1, 2015, at an estimated cost of \$4,869.*

**4. Metro Community Housing Association, 30 Chartwell Lane, Halifax**

The Association incorporated as a non-profit society in 1974 for the purpose of providing supportive housing (group homes, small options houses and supervised apartments) for mental health consumers. In 2005, the society was engaged by the Nova Scotia Department of Community Services to manage client care in a 35-bed residential care facility and a 5-bed transition house both located on Pleasant Street, Dartmouth. Operations are dependent upon core funding from the Province. In 2014, the Association acquired the property on Chartwell Lane, Halifax, to serve as a 4-bed group home for adults with special needs. The property is assessed as Residential (\$5,050). 75% exemption at the Residential rate requested. *It is recommended that Metro Community Housing Association, 30 Chartwell Lane, Halifax, be added to Schedule 28 (50% exemption at the Residential rate), effective April 1, 2015, at an estimated cost of \$2,525.*

**Schedule 29**

**5. BFM Halifax Enterprises Society/BFM Foundation Real Estate Management (2008), 31 Temple Terrace, Lower Sackville – Lease: Conditional - Direct Billing**

The Bibles for Missions Foundation (Canada) is a registered Canadian charity located in British Columbia. The Foundation's purpose is to raise money through a national network of thrift stores for The Bible League of Canada whose stated mission is "propagation of the Gospel", primarily in developing countries. In 2014, the foundation's real estate company (BFM Foundation Real Estate), a registered for-profit business, constructed a retail facility in Lower Sackville which is operated by the non-profit BFM Halifax Enterprises Society under a "stewardship agreement". The property is assessed as Commercial (\$80,219). Full exemption requested. It is recommended that full exemption be declined on the basis that:

- net revenues generated by the operation do not remain within the region to the benefit of local residents;
- the participation of two for-profit entities: BFM Real Estate and BFM Holdings Society - the latter finances real estate development using interest-bearing investments from private interests;
- operations differ from other thrift stores operated by non-profits in receipt of tax relief, including those with a denominational affiliation such as Beacon House Inter-Faith Society and the St. Vincent De Paul Society, insofar as these charities assume greater financial risk through property ownership and do not generate revenue directly or indirectly for private interests.

Partial tax relief recommended. If accepted into the program the property owner must consent to direct billing in care of the tenant and as such accepts the liability should the tenant default on payment. HRM would be obliged to notify the owner of any collection proceedings, lien or judgement against the property. *It is recommended that BFM Halifax Enterprises, 31 Temple Terrace, Lower Sackville, be added to Schedule 29, effective April 1, 2015, at an estimated cost of \$51,057.*

**6. Black Educators Association, 2136 Gottingen Street, Halifax – Conditional: Excludes Residential Assessment**

Founded in 1969, the Association advocates in support of educational opportunities for persons of African Nova Scotia descent including teachers, students, administrators and parents. Services include professional development and educational programs for adults and children. The Association is dependent upon grants from the Province of Nova Scotia, primarily the Department of Education (88% of total revenues) supplemented by grants from the Department of Labour. The property is assessed as Commercial (\$6,617) and Residential (\$1,220). Full exemption requested. Partial tax relief is recommended only for that portion of the premises assessed as Commercial; the two apartments serve

as a source of revenue and are not income-tested or subsidized by the Nova Scotia Department of Community Services. *It is recommended that the Black Educators Association, 2136 Gottingen Street, Halifax, excluding that portion assessed as Residential, be added to Schedule 29, effective April 1, 2015, at an estimated cost of \$4,008.*

**7. Fisherman's Cove Development Association/Nova Scotia Department of Natural Resources, 4 Government Wharf, Eastern Passage Land Lease/Province**

The Association lease 2.4 acres of land from the Government of Nova Scotia for the nominal sum of \$1.00/year for the purpose of local economic development. The lease was for an initial term of 10 years with the option to renew for a further 10 years and expires June 30, 2017<sup>5</sup>. In 2001, the applicant was declined tax relief based on the predominantly commercial nature of facility operations (By-law T-205,

According to the Association's web site (November, 2015), the site accommodates nine seasonal retail shops, three restaurants, and a job search agency. The central administrative building ("interpretation centre") includes the society's administrative office, washrooms, and static displays featuring local history and marine biology. The centre is available for rent to private parties. January 16, 2001, p.4). Conversion from the Commercial (\$21,427) to 75% of the Residential tax rate requested.

The on-site business operations are ineligible for consideration as per Section 71(2) of the *Charter* (2008) that explicitly prohibits tax concessions or other forms of direct financial assistance to a business or industry. The review of this application also considered Section 14A of the *Assessment Act* regarding seasonal tourism operations: this legislation is not applicable because the Association does not own the land or have a 50% share in the business that occupies the premises, or in the case of a corporation 50% of voting shares. Property tax must be recovered from the commercial tenants as determined by the property owner or in this case the tenant holding the head lease with the owner's consent to sub-lease.

The Association is the beneficiary of an income-based assessment classification whereby the market value of the property is directly related to the income generated from its operations<sup>6</sup>. The assessed value and corresponding amount of property tax due may fluctuate year-to-year based on total annual rentals. Under this form of assessment the owner/tenant must remit an annual rent roll to Property Valuation Services Corporation Inc (PVSC). At HRM's request, PVSC has provided a valuation of \$168,900 for 2015 of which \$5,670 (~3.5%) can be attributed to the "interpretation centre". This information was not available to HRM in 2001 when the applicant was declined. *It is recommended that a portion (3.5% comprising the interpretation centre only) of 4 Government Wharf, Eastern Passage, be added to Schedule 29, effective April 1, 2015, conditional upon the exclusion of any commercial activity, including revenue-sharing, dividends, or shares. The cost in 2015 is estimated to be \$3,620.*

**8. Fung Loy Kok Institute of Taosim, 2029 North Park Street, Halifax**

The Institute is a registered Canadian charity that acquired title to the property located at 2029 North Park Street from the Taoist Tai Chi Society of Canada in 2014. The building serves as the Atlantic Region Centre and provides instruction in tai chi. The organization is self-sustaining through instructional fees and fundraising. The property is assessed as Commercial (\$19,820) and Residential (\$2,761). The Residential classification is in error. Conversion from Commercial to Residential rate requested.

Note: Two (2) abutting properties used for private parking are not included in this award. *It is recommended that the Fung Loy Kok Institute of Taoism, 2029 North Park Street, Halifax, be added to Schedule 29, effective April 1, 2015, at an estimated cost of \$11,965.*

**9. Porter's Lake Community Services Association, 4693 Highway #7, Porter's Lake**

In 2012, HRM sold the former Porter's Lake Community Centre to the Association at less than market value. The facility includes a hall and outdoor tennis court. The Association is self-funded through fundraising, hall rentals, and program fees. The property is assessed as Commercial (\$4,050). Full

exemption requested. It is recommended that full exemption be declined: a Conversion from the Commercial to Residential tax rate will reduce taxes payable to \$1,589 in 2015. *It is recommended that the Porter's Lake Community Association, 4693 Highway #7, Porter's Lake, be added to Schedule 29, effective April 1, 2015, at an estimated cost of \$2,423.*

**10. Royal Nova Scotia International Tattoo Society, 2250 Gottingen Street, Halifax**

Incorporated as a non-profit society and Canadian registered charity, the Society is responsible for production of the annual Royal Nova Scotia International Tattoo. The Society is sustained through box office receipts, sponsorship<sup>7</sup>, government grants, merchandising, and fundraising. In 2014, the Society acquired two properties one of which serves as a warehouse and office. The property is assessed as Commercial (\$9,806). Full exemption requested. Note: One (1) abutting property used for private parking is not included in this award. *It is recommended that the Royal Nova Scotia International Tattoo, 2250 Gottingen Street, Halifax, be added to Schedule 29, effective April 1, 2015, at an estimated cost of \$5,951.*

**Schedule 30**

**11. 5534 Almon Street Incorporated, 5534 Almon Street, Halifax Conditional: Excludes Employment-Related Benefit**

In 2014, Northwoodcare Halifax Inc, a registered Canadian charity, transferred "beneficial ownership" of the apartment building located at 5534 Almon Street to an affiliated not-for-profit company named 5534 Almon Street Incorporated. The building contains 66 units of affordable housing of which 25 units are available to tenants of the Metropolitan Regional Housing Authority. One apartment provides housing for a live-in employee and is ineligible for consideration as an employment-related benefit (s.10 of policy). Therefore, tax relief would be applied on a pro-rated basis to 65 of the 66 units. Reinstatement in Schedule 30 recommended. The property is assessed as Residential (\$59,569). *It is recommended that 5534 Almon Street Incorporated, 5534 Almon Street, Halifax, be added to Schedule 30, effective April 1, 2015, at an estimated cost of \$14,929.*

**12. Adsum Association for Women & Children, Unit 209-15 Knightsbridge Drive, Unit 205-110 Farnham Gate Road, and Unit 12-40 Veronica Drive, Halifax**

The Association is a registered non-profit society and Canadian charity that provides housing and support services to homeless and at-risk women and their children. The society is sustained by provincial operating grants and rent subsidies. In 2013, the Association purchased three two-bedroom condominiums that are leased to small families. Tenancy is independent and the duration of lease is unrestricted. The properties are assessed as Residential (combined total of \$5,221). 75% exemption at the Residential rate requested. *It is recommended that Adsum Association for Women & Children, 209-15 Knightsbridge Drive, 205-110 Farnham Gate and 12-40 Veronica Drive, Halifax, be added to Schedule 30, effective April 1, 2015, at an estimated combined cost of \$1,305.*

**13. Albro Court Housing Co-operative Limited, 1 to 24 Cedar Court, Dartmouth**

Incorporated in 1982, the cooperative own and operate six (6) properties each with 4 units for a combined total of 24 units of affordable housing. Revenues are self-generated from monthly rental income with some income-tested assistance from the Nova Scotia Department of Community Services. The properties are assessed as Residential rate (combined total of \$20,130). 25% exemption at the Residential rate requested. *It is recommended that Albro Court Housing Co-Operative Limited, 1 to 24 Cedar Court, Dartmouth, be added to Schedule 30, effective April 1, 2015, at an estimated combined total cost of \$5,034.*

**14. City of Halifax Non-Profit Housing Society, Ck G-2- Payment Plan Compliance**

The Society own and operate a portfolio of affordable housing in downtown Halifax. The subject property (2555 Gottingen Street) comprises twelve (12) units of row housing and is assessed as Residential (\$13,733). Full exemption requested. *It is recommended that City of Halifax Non-Profit Housing Society,*

**15. Newfie Housing Co-Operative Limited, Halifax**

Incorporated in 1981, the cooperative own and operate 12 single-family dwellings in Halifax. Revenues are self-generated through monthly rentals with some income-tested assistance from the Nova Scotia Department of Community Services. The properties are assessed as Residential (combined total of \$22,527). Partial tax relief at 25% of the Residential rate requested. *It is recommended that Newfie Housing Co-Operative Limited, 31, 55 and 61 Abby Road; 99, 108 and 112 Bromley Road; 15 Cavendish Road; 115 Drummond Road; 112, 120 and 188 Ridgeway Road; and 44 Shepherd Road, Halifax, be added to Schedule 30, effective April 1, 2015, at an estimated combined total cost of \$5,562.*

**16. Trillium Housing Co-Operative Limited, 1 to 26 Trillium Court, 66A Valkyrie Crescent, and 49B Cranberry Crescent, Dartmouth**

Incorporated in 1983, the cooperative own and operate 6 multi-unit properties (46 units). Revenues are self-generated through monthly rentals with some income-tested assistance from the Nova Scotia Department of Community Services. The properties are assessed as Residential (combined total \$30,168). *It is recommended that Trillium Housing Co-Operative Limited, 1 to 26 Trillium Court; 66A Valkyrie Crescent; and 49B Cranberry Crescent, Dartmouth, be added to Schedule 30, effective April 1, 2015, at an estimated combined total cost of \$7,542.*

A balance of \$226,997 is insufficient budget capacity for 2016 fiscal year if current levels of exemption were to be renewed. This shortfall in capacity will be due to the addition of Soccer Nova Scotia Training Centre Inc and Feed Nova scotia at full exemption, corrections to Residential assessments (based on use the correct classification is Commercial), additions to the program, and any increase in assessed values not offset by municipal tax rates.

The Grants Committee is a committee of Regional Council comprised of (4) Council members and six (6) members of the public. All organizations in receipt of tax relief are mailed a renewal form in September and new applications are invited through an advertisement placed in the Municipal Notices section of the Chronicle-Herald newspaper.

In accordance with s. 79(2) of the HRM Charter grants and contributions awarded pursuant to s.79(av) are to be publicized in a newspaper circulating within the region.

Presently, groups in receipt of tax relief receive the same level of exemption on fire protection tax. Area rates and mandatory provincial contributions are also included. Local improvement charges, business improvement district levies, fees and fines are excluded from tax relief.			

### Interpretation

Under s.14 of Administrative Order 2014-001-ADM the amount of tax relief provided to an eligible non-profit organization or charity named in a Schedule is equal to a conversion from the Commercial to Residential tax rate, excluding any rates payable as listed in s.15. All organizations on Schedule 29 are assessed at the Commercial rate (based on property use) and receive this level of tax relief.

Under s. 16 there is a *further reduction* that decreases the amount of tax paid at the Residential rate. These deductions are stated as a percentage (%) of the Residential rate and are shown as Schedules 26, 27, 28, and 30. Organizations listed in these Schedules are assessed as Commercial, Residential or Resource and in some cases a combination of two or more assessment categories.

### Terms and Conditions of Funding

- All awards are conditional upon continued compliance with Administrative Order 2014-001-ADM.
- Applicants are screened for debt to the Municipality<sup>8</sup> and registration status. All renewals and additions to the program are conditional upon payment of any prior year arrears or a signed payment plan as applicable. Tax arrears are considered to be amounts outstanding prior to April 1<sup>st</sup> of the current fiscal year. Organizations can also be assisted with cash flow management

through a pre- authorized payment plan whereby taxes are paid in monthly installments.

- Tax relief is not transferable to either another property owned/acquired by the applicant or to another party, including assignment of a lease.
- Recipients of tax relief must notify HRM of any change in use, occupancy (including tenancy or sub-leasing), ownership including but not limited to the sale or conveyance of a property, merger or co-ownership, or the expiry, termination or amendment<sup>9</sup> of a lease agreement as per s.3(i) and (ii) and s.4(b) of the administrative order.
- Currently, non-profit tenants of a property owned by a non-profit or charity included in the tax relief program are covered at the same level granted the non-profit owner. Personal, for-profit, or government tenancy is not covered by the program and is excluded from any tax relief award.

Reasons for removal from the program include: property sale or conveyance, lease expiry or termination, reporting non-compliance (tax relief or grant), a conditional award of limited duration, substantive change in property use, misrepresentation, dissolution, default or loss of registered non-profit status.
