During the month of June, Traffic officers participated in the following events:

On June 1, three members of the Traffic section on police motorcycles attended and provided a safe escort for the Halifax Regional Fire Service in north end Halifax while they conducted a parade to St. Margaret's of Scotland Church during their annual memorial service.

On June 3, Sgt. Reynolds attended a NAOSH safety conference and provided a presentation on distracted driving.

On June 4, Sgt. Reynolds attended the offices of Bell/Aliant Chain Lake Dr. for a "Tailgate" meeting of their installation techs and gave a presentation on distracted driving and covered other motor vehicle related topics.

On June 7, eight members or the Traffic section on police motorcycles attended the annual Ride for Dad cancer awareness and fund raiser and provided a safe escort while 350 motorcycle enthusiasts gathered and participated in a ceremonial ride throughout Dartmouth.

During the week of June 9-11, all 11 members of the Traffic section along with four other police motorcycle operators as well as Cst. Michelle Everson were directed to Moncton to assist during the memorial and funeral services for the three fallen RCMP officers. We provided secure motorcades for the Prime Minister of Canada, the Governor General of Canada as well as escorts for police officers arriving at the airport and being transported to the service by bus. On June 24, Sgt. Reynolds attended a meeting with the Child Safety Link committee.

On June 25, Traffic members were assigned a task to conduct checks of commercial vehicles accessing Otter Lake to dispose of their loads. This is in connection to efforts by HRM to prevent litter falling or otherwise leaking from trucks as they travel along highway 103.

On June 26, Sgt. Reynolds attended the monthly meeting of the Crosswalk Safety Advisory Committee.

On June27, Traffic officers work night shift as part of the National Impaired Driving Enforcement Days program with the following results:

• We did a check point at Waverley Rd. and Rocky Lake Rd. No SOTs or alcohol violations.

- We then went to Magazine Hill and Windmill Rd. and teamed up with RCMP and during this check point eight Draggar tests were conducted with no fails.
- We then set up a check point with RCMP at Cole Harbour Rd. at Portland St. with no SOTs or alcohol violations.
- We were then called to a disturbance at Doolittle bar on Tacoma Dr. to assist shift members. This call turned into a person being in violation of a court order for alcohol consumption which resulted in a foot chase where the individual was eventually caught by K-9.


