Re: September Traffic Section Report

Monthly Theme:

The monthly traffic theme for September was back to school/school bus safety (GO # 15-124045). There were 236 special checks recorded on the file and 140 summary offence tickets generated directly as a result of increased enforcement around schools.

Traffic members spent a considerable amount of time in school zones conducting traffic points handing out pamphlets, setting up radar, dealing with parking and driving complaints and generally just being visible around schools in the region. We were approached by many staff and parents from the schools thanking us for the extra efforts. We also assisted with many of the lock down exercises at various school and assisted school officers with chronic parking issues.

There were two information/educational based Facebook postings added to Traffic Cop page in September.
