Environmental Scan of 2013 4th Quarter

Total District Criminal Code Offences/Drugs

Total Criminal Code offences in the fourth quarter of 2013 show a **decrease** of -85 or by -6.14% compared to the fourth quarter in 2012.

Drugs for the fourth quarter of 2013 **decreased** by -17 or by 11.3% compared to the fourth quarter of 2012.

In the fourth quarter Property offences reported accounted for 52% of Total Criminal Code offences, while crimes against Persons accounted for 13% and Other Criminal Code offences accounted for 33%.

Fourth Quarter comparison between 2012 and 2013:

Property Crimes

Overall Property Crime **decreased** by -80 or -10.57%.

Stolen Motor Vehicles **decreased** by -8 or -14.55%.

Break and Enters **decreased** by -34 or -23.61%.

Fraud incidents **decreased** by -4 or -5%.

Violent Crimes

Overall Violent Crime **increased** by +14 or +9.09%.

Robberies remained the same at 12.

Homicides **decreased** by -1 or -100%.

Attempted Murders **increased** by +2 or +100%.

Assaults **increased** by +13 or +9.29%.

Assaults accounted for 91.07% of reported violent crimes in the fourth quarter of 2013.

Other Criminal Code

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (i.e. arson, property damage, indecent acts, counterfeiting currency etc.)

Offensive Weapons **increased** by +3 in the fourth quarter of 2013 or +13.04.

Moral offences **increased** by +2 in the fourth quarter of 2013 or +100%.

Environmental Scan of 2013 Calendar Year

Total District Criminal Code Offences/Drugs

Total Criminal Code offences in 2013 show a **decrease** of -525 or by -8.86% compared to 2012.

Drugs for 2013 **decreased** by -64 or -11.05% compared to 2012.

In 2013 Property offences reported accounted for 54% of Total Criminal Code offences, while crimes against Persons accounted for 13% and Other Criminal Code offences accounted for 33%.

Calendar Year comparison between 2012 and 2013:

Property Crimes

Overall Property Crime **decreased** by -352 or -10.86%.

Stolen Motor Vehicles **decreased** by -10 or -5.49%.

Break and Enters **decreased** by -137 or -24.86%.

Fraud incidents **increased** by +41 or +14.14%.

Violent Crimes

Overall Violent Crime **decreased** by -26 or -3.69%.

Robberies **decreased** by -14 or -28.57%.

Homicides **decreased** by -2 or -50%.

Attempted Murders **increased** by +3 or +60%.

Assaults **decreased** by -15 or -2.35%.

Assaults accounted for 91.89% of reported violent crimes in 2013.

Other Criminal Code

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (i.e. arson, property damage, indecent acts, counterfeiting currency etc.)

Offensive Weapons **decreased** by -22 in 2013 or by -18.03%.

Moral offences **increased** by +5 or +250% in 2013.

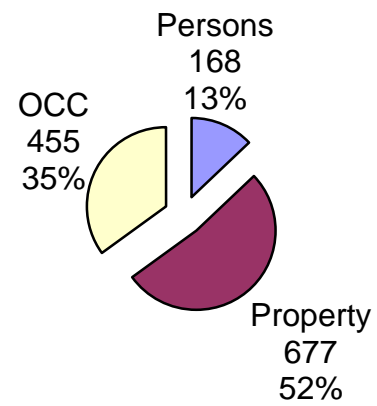
**Crimes Against Persons

2012-2013**

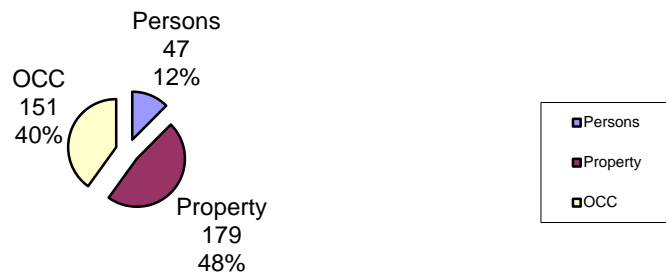

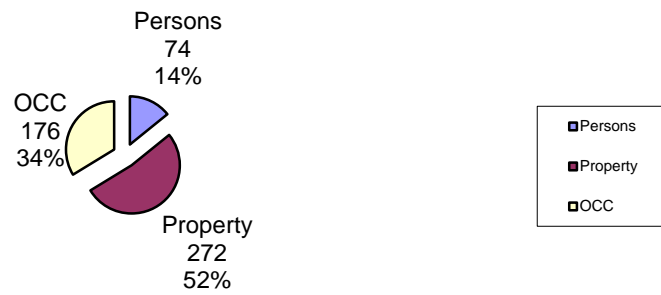

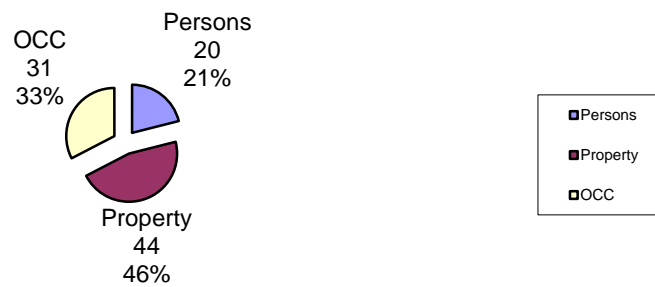
RCMP Halifax District 4th Quarter Stats Cole Harbour



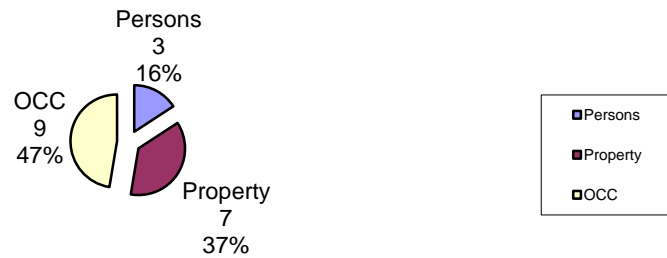
RCMP Halifax District 4th Quarter Stats Lower Sackville

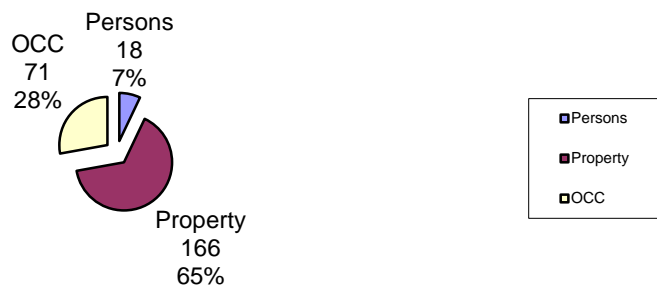

Assault with a Weapon Causing Bodily Harm accounted for 15% of the total Assaults in 2013 compared to 17% in 2012 and experienced a -4% **decrease** over the same period last year.

All forms of Sexual Assaults combined accounted for 10% of the total Assaults in 2013 compared to 16% in 2012.

Total HRM Criminal Code Offences/Drugs

Total Criminal Code offences reported in the fourth quarter of 2013 show a **decrease** of -282 reported offences or a **decrease** of -5.12% compared to the fourth quarter of 2012. Drugs in the fourth quarter of 2013 show an **increase** of 14 offences or an **increase** of 4.50% compared to the fourth quarter of 2012.

Property offences account for **55%** of the reported Total Criminal Code offences, while crimes against Persons account for **13%** and Criminal Other offences account for **32%**.

Property Crimes

Property crime shows a **decrease** of -99 reported offences or -3.31%.

Stolen motor vehicles **decreased** by -25 offences or -16.56%.

Break and Enters **decreased** by -56 offences or -15.09%.

Frauds **decreased** by -35 offences or -10.20%.

Violent Crimes

Violent crime has experienced a **decrease** in the fourth quarter of 2013 compared to 2012 by -32 offences or a change of -4.51%.

Robberies **increased** by 8 offences or a change of 14.29%.

Homicides **increased** by 1 incident in 2013 compared to the fourth quarter of 2012 or 100%.

Attempted murders **increased** by 6 offences in the fourth quarter of 2013 or a change of 200%.

Assaults **decreased** by -50 offences or a change of -7.81%. Assaults accounted for 87% of violent crimes in the fourth quarter of 2013.

Criminal Other

Includes prostitution, gaming/betting, offensive weapons, and other criminal code offences (arson, property damage, indecent acts, counterfeiting, etc) has **decreased** by -151 or -8.32%.

Prostitution offences **increased** by 12 offences in the fourth quarter of 2013 over 2012 or 1200%.

Please note offences such as drug and prostitution are sensitive to directed enforcement and detection.
