Motion from the July 2, 2015 meeting of the Environment and Sustainability Standing Committee

# LEGISLATIVE AUTHORITY

# ORIGIN

Environment and Sustainability Standing Committee October 6, 2011, Item 7.1.4 – Save Our Lakes Actions.

Motion: that the Environment and Sustainability Standing Committee direct staff to:

- 1. Provide an update on the harmonization of the Lot Grading By-Law;
- Create a Water Issues Advisory Group for a term of 12 months with a mandate to work with staff on the priority actions of the Save our Lakes project as identified by the Environment and Sustainability Standing Committee;
- 3. Prepare an Annual State of the Lake Report in conjunction with the Water Issues Advisory Group;
- 4. Identify possible opportunities and best management practices for inclusion of Green Infrastructure in the Red Book and for municipal internal practices;
- 5. Develop a draft statement on Provincial Water Resource Management Issues for endorsement of the Environment and Sustainability Standing Committee; and
- 6. Request an update from Halifax Water on the progress and scope of the Waste Water Management Functional Plan.

This report responds exclusively to item 3 of the motion identified above.

# LEGISLATIVE AUTHORITY

Lakes are under the Legislative Authority of the Province of Nova Scotia under The Environment Act.

The Municipality has Legislative Authority in the Halifax Regional Municipality (HRM) Charter to enact bylaws, manage development, create policies, and expend money in a variety of authorities that may affect water quality.

### RECOMMENDATION

It is recommended that the Environment and Sustainability Standing Committee direct this report to the Regional Watersheds Advisory Board for its information.

### BACKGROUND

The Environment and Sustainability Standing Committee issued direction to staff to prepare an annual State of the Lake Report in October 2011.

### DISCUSSION

Water quality sampling continues at selected HRM lakes in accordance with four disparate programs operated for distinct purposes: beaches (public safety); blue flag (public safety & certification); development agreements (performance assessment: trophic status & public safety); and watershed studies (assimilative studies (assimilative capacity assessment per Regional Plan (2006) Policy E-17.

The report compiled summaries of the performance and key observations from each of the four programs over 2014, including recommendations for future water quality monitoring as generated by the watershed studies presented to Regional Council, Community Council and the Regional Watershed Advisory Board in 2014. It also profiles a new water quality monitoring project commissioned in 2014 to run from 2015 through 2017.
