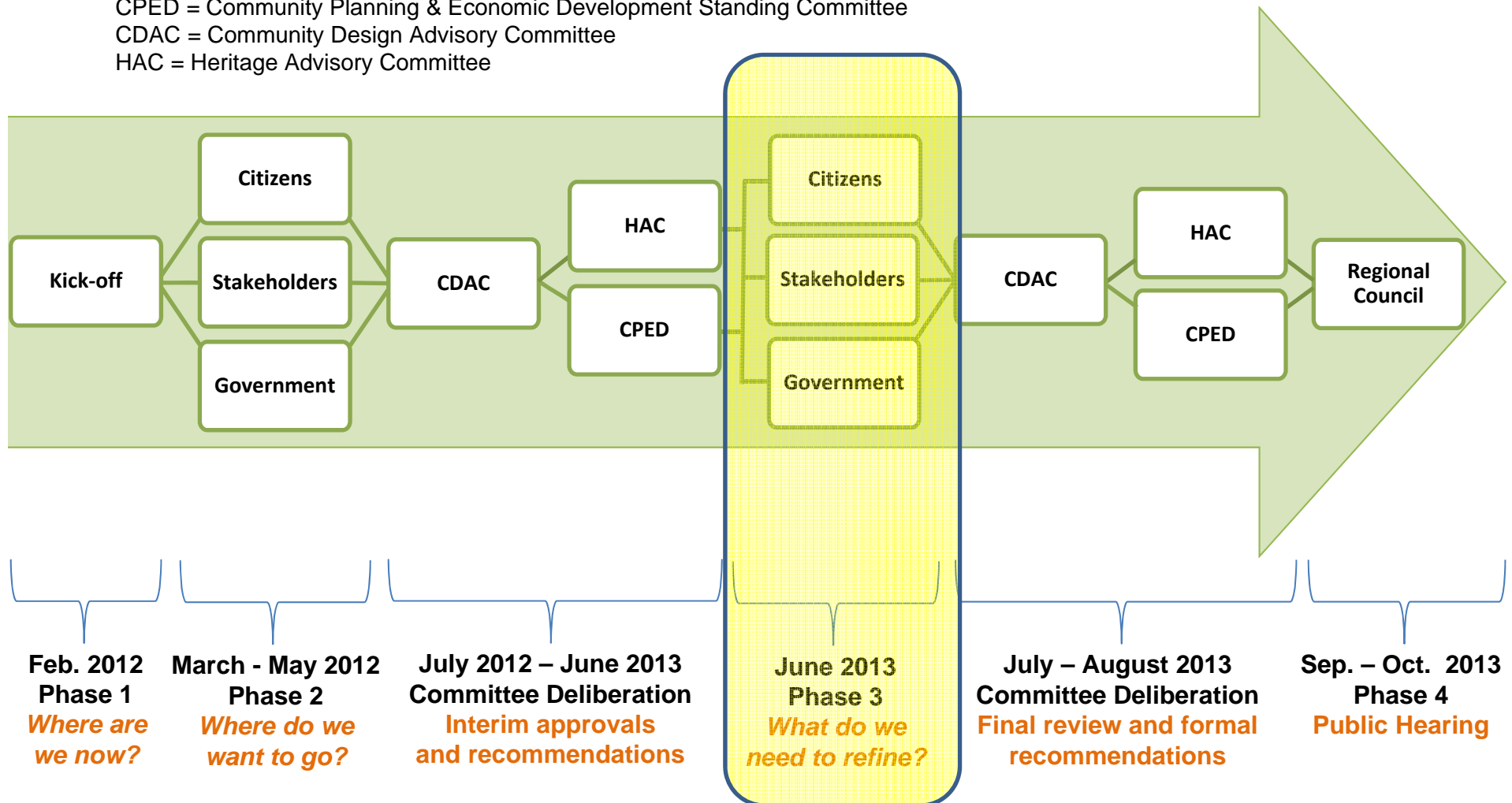

- **Professionally facilitated**
- **3 half-day sessions with groups**

 - Vibrant (Culture, Heritage, Arts, Business)
 - Sustainable and Mobile (Environment, Transportation and Health)
- **Will include:** early invitation, background materials, presentation, group discussions on sub-topics, comment and evaluation forms, written submissions, follow-up.

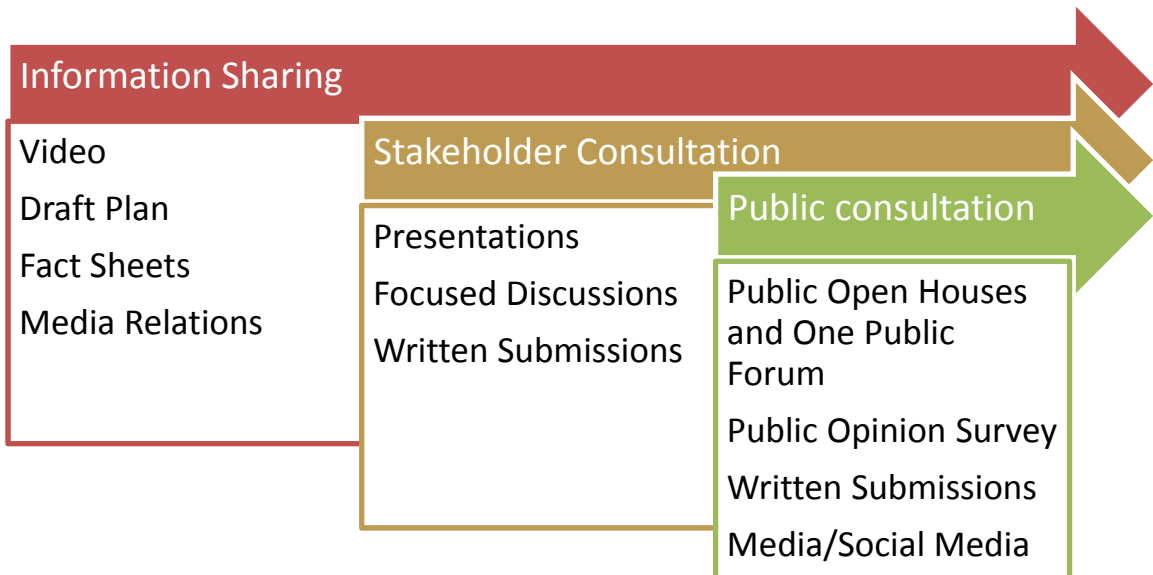
Public Consultation

- 3 Open Houses (Clayton Park, Fall River, North Preston)
- 1 Regional Open House and Public Forum (Dartmouth)
- Written and on-line submissions
- Public opinion survey
- **Will include:** fact sheets, posters, comments and dot-democracy at the open houses, comment and evaluation forms, Q&A at the public forum, written submissions.

Policy-specific (examples)...

- Do you agree that HRM should increase protection of watercourse buffers on private properties?
- How supportive are you of a Transit Service Boundary to improve the quality and reliability of transit in high density areas?
- How supportive are you of HRM phasing-in undergrounding telecom and power lines in existing areas, and requiring it in all new communities?
