- Vibrancy of the arts community
- Diversity

- (1990's not much is working; 1999 nothing recognized since then since original plan, except staff hiring because we haven't defined investment
- Hill study did our own #'s
  - Can't fund individual artists
  - Artist in residence
- Supplementary funding / Civic events have to measure apples against apples
- Halifax charter
- People oriented

## Question 3 – How could the draft plan be further refined; what needs to change?

Refinements - Table 1

- Clear definitions of 'culture', 'heritage', 'arts'
- Recognize in the plan these activities are important
- Integration the Regional Plan must be cross-referenced with other plans; not viewed as a stand-alone
- Investment not simply viewed as a land use document; clear measures and clear actions
- Taxation review needed

• Stable funding, including the professional arts

Refinements – Table 2

- Engagement of community (metric) go beyond an inventory of buildings and people leading to better policy development
- Identify the stewardship role
- Culture and Heritage must be informed by stewardship
- Address the storage of artifacts
- Differentiate between Culture, Heritage, Arts they are related, but they have their own unique needs
- Arts & Culture & Heritage projects within our recreation facilities (integration)
- Sustainability and financial considerations:
  - Lost local area rates @ amalgamation
  - Loss of predictable funding

<u>Refinements – Table 3</u>

- Take the view beyond a land use plan with respect to Culture, Heritage and the Arts
- 35,000 new dwelling units can be accommodated (Stantec) without going into existing neighborhoods; be creative about what can go on vacant lands
- Provide clear timelines to address issues before what we have is gone!
- Leave stable areas alone
- Leave existing plans residential, commercial, etc. alone and instead focus on opportunity areas
- Chapter 7 more robust re arts, culture, heritage

What is NOT working in the plan?

- Measureable for investments not defined
- Needs to be foundation of engagement
- Better definitions
  - We are all very distinct
- What's been identified in objectives need more specific targets and outcomes
- Are people engaged? How do we measure that?
- It's day-to-day for many organizations
  - $\circ$   $\,$  Keeping the doors open  $\,$

- Need to reflect WHO our community is.
- Museums
  - Programming gives value to community?
- Page 74 Phase One: Inventory:
  - "Aboriginal and diverse ethnic cultures" suggest, "Aboriginal, Acadian and African Nova Scotian..."
- Add another Arts, Culture & Heritage objective:
  - "Ensure opportunities for cultural activity and for creative economy"
- Reference Greater Halifax Arts Coalition
- Section 2.5.2 (page 34) the Community Energy Plan is presented in much more detail; please provide the same level of detail (objectives) from the Cultural Plan of 2006
- Should the section be split?
  - Arts & Culture / Heritage
- Page 73-75 "Culture" Section
- Pages 75-81 "Heritage" Section

## Question 4 – What does successful implementation look like?

- Refined program funding
- Reaches beyond festivals and events
- Steps are taken to address the gap to professional arts funding
- The need for investment is acknowledged
- The economic underpinnings are understood stable, specific, long term
- More flexibility in terms of land use planning and partnerships that can be developed use of spaces, both public and private (for broader use)
- The value of cultural clustering and resource sharing is acknowledged
- There is collaboration within existing programing (i.e. trail groups)
- A risk assessment is completed within 5 years!
- There is greater integration of culture, heritage and the arts in the schools
- Archives we have a plan around this within 5 years
- The inventory comprehensive, needs time and resourced (do this = good product) and use to inform policy and program development
- The municipal responsibility to the Dartmouth Heritage Museum address immediately

- A heritage committee is established to compliment the new ad-hoc arts advisory committee
- Culture and Heritage staff component needs to be there to do a good job
- Accessibility (in many different forms!)
- Investment is measured apples to apples
- The value of supporting Arts, Artists & Arts Institutions (professional) is defined
- Investment of time is valued
- There is commitment to follow through
- We keep listening to other voices
- We know who we are and the way we live
