Committee Recommendations

ORIGIN

December 10, 2014 – Council approved development and implementation of a Municipal Commemorative Program for the 100th Anniversary of the Halifax Explosion.

January 14, 2015 – Halifax Explosion 100th Anniversary Special Advisory Committee develops the Vision Statement and Guiding Principles and forwards to staff for approval by the Community Planning & Economic Development Standing Committee.

February 12, 2015 – Community Planning & Economic Development Standing Committee approval of a Vision Statement and Guiding Principles developed by the Halifax Explosion 100th Anniversary Special Advisory Committee.

September 16 and October 21, 2015 – Meetings of the Halifax Explosion 100th Anniversary Special Advisory Committee.

LEGISLATIVE AUTHORITY

The Terms of Reference of the Halifax Explosion 100th Anniversary Special Advisory Committee are provided in *Administrative Order 2014-005-GOV*, Respecting the Special Advisory Committee on the 100th Anniversary of the Halifax Explosion.

RECOMMENDATION

The Halifax Explosion 100th Anniversary Special Advisory Committee puts forward for staff consideration the recommendations contained in Attachment 1 of this report.

BACKGROUND

The Halifax Explosion 100th Anniversary Special Advisory Committee (HEAAC) was formed by Regional Council adoption of Administrative Order 2014-005-GOV on June 10, 2014. The HEAAC is mandated to advise staff on the development and implementation of the Municipal Commemoration Program in recognition of the 100th Anniversary of the Halifax Explosion. As approved by Council, the Municipal Commemorative Program consists of the following three elements:

- A civic commemorative event led by HRM that will include elected officials from the Government of Canada, the Province, and HRM, as well as community leaders and members of the general public;
- 2. A legacy capital project; and
- 3. A designated grant program to fund non-profit organizations and registered charitable organizations located in HRM to deliver local projects in their communities in recognition of the significance of the 100th anniversary of the Halifax Explosion.

Through its deliberations, the HEAAC developed a Vision Statement (Attachment 2) and Guiding Principles (Attachment 3) with the aim to guide the work of committee members, staff, and elected officials in the design and implementation of the Municipal Commemorative Program. During the HEAAC deliberations, it was recognized that there is but one opportunity to properly commemorate the 100th anniversary of the Halifax Explosion and that there should be series of events leading up to the civic commemorative event on December 6, 2017. The HEAAC further noted that other commemorative events may also be conducted on December 6, 2017. As such, it is recommended that Element 1 of the Municipal Commemorative Program should be comprised of the following two sub-components:

- a. December 6, 2017 Expanded Commemorative Ceremony; and
- b. 100th Anniversary Commemorative Program.

In advancing this recommendation, the HEAAC then reviewed suggestions and proposals submitted by various organizations and individuals, and ideas generated by the HEAAC members themselves resulting from a workshop meeting held on Wednesday, September 16, 2015. The HEAAC further refined its recommendations at its regular meeting held on Wednesday, October 16, 2015.

DISCUSSION

Methodology: All proposals, concepts and ideas were reviewed and categorized under one or more of the Guiding Principles and assigned a recommendation as follows:

- Proposed project is recommended for funding and management by the Municipality and should be referred for review and development by Staff. List A in Attachment 1.
- Proposed project should be referred for possible consideration under a municipal grant program or potential participation in the civic commemoration. A letter would be sent by staff to the proponent to confirm their eligibility for municipal funding, if applicable, and guidance as to the selection of program and/or timing. List B in Attachment 1.

• Proposed project is referred to staff to determine what options may exist to address the proposal. Projects in this category would unlikely be financed by the Municipality and/or be eligible under the Explosion Grants Program. List C in Attachment 1.

SUMMARY - 100TH ANNIVERSARY COMMEMORATIVE PROGRAM

Notwithstanding the undetermined status of ideas and concepts outlined in List C of Attachment 1, the HEACC recommends that the proposals contained in List A be incorporated in a 100th Anniversary Commemorative Program. The HEAAC has assigned a priority of High, Medium, or Low for the List A proposals. This prioritization is based on several considerations including: cost, impact, complexity in planning and execution, and Guiding Principles met. It is further recognized that the List A proposals are broad in complexity and scope and the staff capacity to develop certain proposals may not exist or is limited. Therefore, the List A proposals are further categorized into two broad areas as follows:

1. <u>Civic Commissions</u>: These recommended projects are considered high profile, complex in scope or technical standards and may exceed the financial and human resource capacity of a non-profit organization and/or the human resource capacity of HRM. Consideration should be given to commissioning an external organization or individual to manage a project.

Halifax Explosion 100th Anniversary Commemorative Program Vision Statement

The most destructive, human-made explosion of the pre-atomic era occurred in Halifax Nova Scotia on the morning of December 6, 1917. It resulted from a collision and fire on board a munitions-laden freighter attempting to pass through the Narrows into Bedford Basin. Ignition of the vessel's lethal cargo sent a wave of destruction across the city. Worst hit were the northern sections of Halifax and the town of Dartmouth; thousands were killed, maimed, and left homeless.

The disaster became a pivotal moment in this city's history, prompting a massive mobilization of human and material resources to engage in a multi-faceted program of rescue, reconstruction and rehabilitation. Halifax, the nation, and indeed all those across the world who became involved with the explosion, now stand at the threshold of the explosion's centennial.

Vision Statement:

The Halifax Explosion 100th Anniversary Commemoration will honour the memory of those who died and suffered as a result of the explosion, will educate current and future generations about the significance of the event, and will celebrate the resilience of Halifax in rising from destruction to restore the full potential of the city and its people.

Halifax Explosion 100th Anniversary Commemorative Program Guiding Principles

- 1. It will be a solemn, respectful and reflective commemoration honouring the victims of the Halifax Explosion, the response, and the legacy.
- 2. It will acknowledge and tell the diverse personal, national and international story, which had a lasting legacy.
- 3. It will reflect diversity of all the communities impacted such as relatives of survivors, African NS and Mi'kmag communities.
- 4. It will educate and connect people, particularly youth, to the history and meaning of the Halifax explosion in different ways.
- 5. It will encourage community members participate through a variety of cultural and creative modes.
- 6. It will capture the local and National imagination and attention.
- 7. It will acknowledge and explore the scope of the compassionate response.
- 8. It will explore institutional responses to the impact of disaster, including within the context of war.
- 9. It will have a perpetual meaning for future generations.
- 10. Its legacy projects will strive to be compelling, meaningful, evocative and an enduring commemoration.
