- March 27, 2007 Civic Event Granting Policy & Framework
- SEAC Terms of Reference:
 - "SEAC shall review, evaluate and make recommendations to Regional Council in regard to the allocation of the annual Special Event Reserve, Festivals & Events Grants and the Summer Festival Grants pursuant to the HRM Civic Events Policy Framework"



Funding Sources

- Operating Budget for Culture & Events (C760)
 - Annual Budget Approval Process
 - Festivals & Events \$25,000
 - Summer Festivals \$25,000
 - Annual Events \$66,000



C760 Event Programs

- Festivals & Events
 - Non-profit organizations for new, recurring and annual small scale community events
- Summer Festivals
 - Events located within the former Halifax County
- Annual Events

Funding Sources

- HRM Marketing Levy Reserve (MLSER) (Q315)
 - By-Law H-400 Respecting the Marketing Levy
 - 40% of the 2.0% levy 60% goes to DH
 - \$1.2 million
 - Hallmark, Tourism, Exception & Major Civic Celebration Programs



MLSER Event Programs

- Hallmark \$400,000 in 2014
 - Recurring event possessing such significance in terms of tradition, attractiveness, image or publicity that it provides the host community with a competitive advantage
- Exception \$231,000 in 2014
 - When requests fall outside the approved policy



MLSER Event Programs

- Tourism
 - Major events that attract tourists to HRM for multiple day visits
- Major Civic Celebration
 - Events celebration significant anniversaries

- Special application process
 - Hallmarks
- No application process
 - Annual Events



Grant Application Process

- · Organizations submit an application to HRM staff.
- HRM Civic Event staff review & create report for SEAC
- HRM Civic Event staff SEAC Reviews & makes recommendations to RC
- RC Reviews & makes final recommendations
- · Successful applicants are notified
- Grant agreements forwarded by staff
- Applicants complete agreements
- Grant award released 80% / 20%
