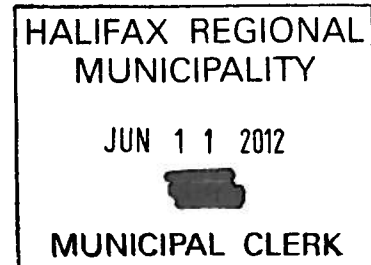

Dear members of the Environment & Sustainability Standing Committee,

The Our HRM Alliance requests time on the agenda of the July 5 meeting of the Environment & Sustainability Standing Committee to present on the first of its "Seven Solutions" for making the Municipality more sustainable and more liveable.

The first of these "Seven Solutions" is to "use greenbelting". The Our HRM Alliance released its greenbelting to the public on March 19, 2012. Now it would like the opportunity to present this solution directly to the Municipality's decision makers.

The Our HRM Alliance consulted heavily to produce both policy documents and a map that outlines four zones which would, when put together, clearly demonstrate where growth should happen and where growth should be restricted. The greenbelting solution is not about limiting developing. It is about channelling low impact development to the most ideal places.
