Case # 00798: Time Extension to Sign Development Agreement

## SUPPLEMENTARY REPORT

## **ORIGIN**

Request by EDM Limited for a time extension for signing the approved development agreement for the former Dartmouth Marine Slips property, Alderney Drive, Dartmouth.

## **RECOMMENDATION**

It is recommended that Harbour East Community Council require the development agreement for the former Dartmouth Marine Slips property, Alderney Drive, Dartmouth, be signed within 120 days of the date of this granted extension, or any additional extension thereof granted by Council on request of the Applicant. Otherwise this approval shall be void and any obligations arising hereunder shall be at an end.

# BACKGROUND /DISCUSSION

On August 7, 2008, Harbour East Community Council approved the Stage I development agreement to permit a mixed-use development on the former Dartmouth Marine Slips property, Alderney Drive, Dartmouth (Map 1). On that date, Council required that the development agreement be signed within 120 days following the expiry of the appeal period. The appeal period expired on Monday August 25, 2008 and 120 days will have passed as of December 23, 2008.

A time extension of 90 days is requested by the applicant to address land ownership issues relative to the development. Staff are of the opinion that the requested extension is reasonable in light of the size and complexity of the development. Further, staff recommend Council consider a 120 day time extension to provide an adequate timeframe for completion of the land ownership issues.

## **BUDGET IMPLICATIONS**

The Developer will be responsible for all costs, expenses, liabilities, and obligations imposed under or incurred in order to satisfy the terms of this Agreement. The administration of the agreement can be carried out within the approved budget with existing resources.

# FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation.

## **ALTERNATIVES**

- 1. Community Council may choose to approve the requested time extension for signing the development agreement by 120 days. This is the recommended course of action.
- 2. Community Council may choose to not approve the requested time extension for signing the development agreement which would render the agreement null and void and any obligations arising under it to be at an end after December 23, 2008. This is not recommended.


