**ORIGIN**

Appeals Committee meeting held on March 2, 2004.

**RECOMMENDATION**

It is recommended that Regional Council:

1. Approve in principle the amendments to By-Law T-108 found in Appendix "A", of this report, and direct staff to arrange for their formal adoption by Council.

### **BACKGROUND**

As the result of an appeal heard on January 26, 2003, the Committee requested that Mr. Anstey bring forward an amendment to By-law T-108 which would ensure that the taxi vehicle owner be required to show proof that he/she has advised the insurance company to notify the Taxi Licensing Office of any change to his/her insurance.

### **DISCUSSION**

During his presentation of the facts of the abovementioned appeal, Mr. Steele advised that the insurance on the vehicle in question had been cancelled months prior to the expiry date on file with the Taxi Office. He further indicated that the Taxi Office is in some cases made aware that the insurance has been cancelled by the Insurance Company and in others are not. In an effort to ensure greater consistency, the Committee requested the Solicitor prepare an appropriate amendment.

### **BUDGET IMPLICATIONS**

There are no budgetary implications inherent in this document.

HALIFAX REGIONAL MUNICIPALITY

BY-LAW NUMBER T-129

RESPECTING THE REGULATION OF TAXIS AND LIMOUSINES

BE IT ENACTED by the Council of the Halifax Regional Municipality, under the authority of Section 305 of the Motor Vehicle Act, Chapter 293, R.S.N.S. 1989 that By-law T-108, the Halifax Regional Municipality Taxi and Limousine By-law be and the same is amended as follows:

1. Subsection (1) of Section 12 of said By-law T-108 is amended by adding immediately following clause (v) thereof, the following clause:

(vi) The applicant deposits with the Inspector written proof that the applicant has requested the insurance company issuing the insurance policy pursuant to clause (v) to advise the Inspector of any change to the coverage and terms of the insurance policy issued to the applicant and to notify the Inspector when the insurance policy is no longer in effect.
