SUBJECT: Award of Tenders #04-024 and #04-025 - Fleet Vehicles

ORIGIN

2003-2004 Approved Capital Budget

RECOMMENDATION

It is recommended that Regional Council award:

- 1. Tender #04-024 to Steele Ford Lincoln for a total contract cost of \$ 51,652.12 including net HST, the lowest bidders meeting specifications from Capital Account No. CVD00413, Fleet Vehicle Replacement Program, with funding authorized as per the Budget Implications section of this report.
- 2. Tender #04-025 to LaHave Equipment for a total contract cost of \$ 223,176.29 including net HST, the lowest bidders meeting specifications from Capital Account No. CVD00413, Fleet Vehicle Replacement Program, with funding authorized as per the Budget Implications section of this report.

BACKGROUND

Tenders were issued on January 26, 2004, for the supply and delivery of the following vehicles:

- a) Two (2) 2004 Model Cargo Vans 9,600 G.V.W.
- b) One (1) 2004 Model Front End Loader (Rubber Tire Mounted) Four Cubic Yard Capacity

These vehicles are required to replace units currently in operation that are beyond their life expectancy.

DISCUSSION

Tenders were publicly advertised. The following bids were received, evaluated and recommended by Fleet Services.

TENDER 04-024, Two (2) 2004 Model Cargo Vans - 9,600 G.V.W.

LaHave Equipment, the lowest bidder meeting specifications, is the recommended bidder.

BUDGET IMPLICATIONS

Based on the contract cost of \$274,828.41 including Net HST for Tenders #04-024 and #04-025, funding in the 2003/2004 Approved Capital Budget under Account No. CVD00413, Fleet Vehicle Replacement Program is available as follows:

The availability of these funds have been confirmed by Financial Services. The net HST has been included in the award amount. The Federal Government, in the recent speech from the throne, has proposed changes that would provide a GST rebate to Municipalities. This legislation, once approved, will affect the total cost of this award. Once the legislation is in place, and the actual amount determined, the value will be adjusted accordingly.
