Re: Committee on the Whole - Budget Discussions

Councillor Hendsbee,

The below noted correspondence is in reply to the questions posed to me during my presentation to Council on April 13 2004. Unfortunately, the list of questions were never sent to me directly, however I did receive them from the office of Chief Beazley, Halifax Regional Police. As a result there was a delay in responding to these questions.

As a point of clarity, I have taken the liberty to respond the questions, as they were asked. I hope that you will find my responses to meet with your needs.

Q. More detailing of RCMP expenditures (preferably by Detachments)

A. The matter of a detailed list of RCMP expenditures is more appropriately addressed with the HRM's contracting partner. This correspondence is not generated by the RCMP, but rather by the Province of Nova Scotia. Halifax Detachment is not able to influence the manner in which this information is provided to the HRM by the Province.

Q. Number of officers on secondment/overseas duty that on our payroll, but servicing elsewhere

A. Currently, there are no officers from Halifax Detachment that are deployed oversees that are on the HRM's payroll. Halifax Detachment has recently transferred one of its members to a United Nations mission, but his salary is paid for from the RCMP's National Program. Halifax Detachment has one member seconded to the Community Response Initiative, but this position is back-filled by an additional member assigned to Halifax Detachment, partially paid for by the HRM. As of this date, Halifax Detachment has a surplus of members working in the HRM than it pays for.



- Q. Program Delivery/Level of Services
 - a. Lake Patrol in light of recent CCG boating regulations) Level of Presence on local Lakes (Porters Lake & Lake Charlotte primarily)

A. There is no intention to conduct a dedicated lake patrol within Halifax Detachment primary policing jurisdiction this year. However, Halifax Detachment members will partner with the Canadian Coast Guard and other agencies to conduct appropriate patrols as opportunities arrive.

Q. Status of Off Highway Patrol to respond to complaints of ATV traffic and other initiatives started to monitor trail activity.

A. This matter was address during my presentation to council on April 13, 2004. However, I will reiterate my comment that Halifax Detachment has partnered with Halifax Regional Police to conduct dedicated ATV patrols within the HRM. An operational plan is in place to deal with this issue. It is our intention to report our results to the Board of Police Commissioners and to share this information in an appropriate manner.

Q. What level of support for Citizen on Patrol and Community Policing Office support.

A. Halifax Detachment Management will continue to support the Citizen on Patrol program as we view it as a vital component to our volunteer response to policing and community issues. We will continue to support the current community policing offices. However, as discussed in my presentation to council on April 13, 2004, it is our intention to replace the single dedicated community policing officer with a team of dedicated officers from our patrol section to ensure that our various communities are provided a more efficient and effective level of service.

Q. What level of School Program support (i.e. Liaison officers in the schools, DARE in Elementary and Safe Grad programs).

A. Halifax Detachment will continue to support the current level of representation and program delivery within our schools policed in our primary policing jurisdiction. Over this last year, Halifax Detachment increased the number of officers within our schools from five to six. This is further supported by a change within our operations to use these dedicated resources outside of the school hours(summer holidays) to be devoted to youth-related issues within our communities.

Q. Impact on level of service and response time of reassignment of officers and/or realignments of detachment boundaries (Cole Harbour& Musquodoboit Harbour (Route #207 and Porters Lake).



A. I am not sure that I totally understand what is being asked by this question. However, as previously stated within this document and during my presentation to council, the changes that are being made within our zone patrol model will ensure that our response times to calls for service are kept to an acceptable level. If and when this can no longer occur, adjustments will be made in the manner in which we deploy our resources with full consultation with our policing partners, clients and stakeholders.

Q. What plans are in place re continuance of Community Constables Program and other Community & Race Relation initiatives (more support efforts needed).

A. Halifax Detachment is at the forefront in the various initiatives that will enhance our relationship with our diverse communities. Programs, initiatives and policing response will be adjusted in a matter to ensure that we are able to meet the needs of our diverse and other communities. The Community Constable Program as previously experienced will not be implemented in the immediate future. The RCMP Halifax Detachment will once again participate in its national summer student program, which will offer some of the same benefits previously found in the Community Constable Program.

Breakdown of staff recommended enhanced Sportsfields, Trails and Parks budget:

Parks, Trails and Sportsfields - \$ 485,000

Responding to the Healthy Sustainable Vibrant Communities and Safe Communities themes:

- \$60,000 Playground Upgrades for General CSA compliance
- \$25,000 Sportsfield Upgrades for one irrigation project (field to be determined)
- \$50,000 Sports Courts Upgrades for resurfacing one court (to be determined)
- \$50,000 Walkway Upgrades for general upgrades
- \$60,000 New Playground Development (Joshua Slocum in District 22 and Bissett Lake Estates in District 5)
- \$200,000 Parkland Reserve trails
- \$40,000 Parkland Reserve Plan for western commons

Will HRM be covering 50% of new sidewalk in Prospect area?

The issue is that the Route 333 (Prospect Rd, Brookside Dr to Elementary School) sidewalk is outside the core and therefore not eligible for 50% cost sharing from HRM. This means that \$145,500 of the \$776,000 set aside in this capital supplementary report on page K3 of the proposed capital budget book for 04/05 will not be spent on this project. (the funds will have to come 100% from area rate as Department of Transportation does not cost share on sidewalks).
