## **ORIGIN**

Approved 2003/04 Capital Budget

## **RECOMMENDATION**

It is recommended that Regional Council award Tender 03-114R to Carroll South Shore Motors the lowest bidder meeting specifications in the amount of \$53,000.00 plus net HST for a total cost of \$56,407.37 from Capital Account No. CVD00433, Service Vehicle Replacement, with funding authorized as per the Budget Implications section of this report.

#### BACKGROUND

The Halifax Regional Municipality publicly advertised tenders from qualified dealerships and firms to supply and deliver vehicles for Fleet Services, Real Property and Asset Management.

A tender was issued for the supply and delivery of two (2) 2004 4-Door Sedan Heavy Duty Vehicles (Front Wheel Drive), to replace two (2) 1998 4-Door high mileage sedans, used as road service vehicles, in the Metro Transit Operations Dept. The tender only yielded one bid the first issue so it was reissued.

#### **DISCUSSION**

Tenders were sent to qualified firms for the above noted vehicles. The following bids were received, evaluated and recommended by Transit Services and Fleet Services.

One other bid was received from Blaikies Dodge Chrysler but did not meet specifications in a number of areas. Staff is therefore recommending that the lowest bidder meeting specification, Carroll South Shore Motors, be awarded the tender.

### **BUDGET IMPLICATIONS**

Based on a total award of \$56,407.37 including net HST, funding is available for this tender in the 2003/3004 Approved Capital Budget under Account No. CVD00433, Service Vehicle Replacement Program. The budget availability has been confirmed by Financial Services.

The net HST has been included in the award amount. The Federal Government, in the recent speech from the throne, has proposed changes that would provide a GST rebate to Municipalities. This legislation, once approved, will affect the total cost of this award. Once the legislation is in place, and the actual amount determined, the value will be adjusted accordingly.
