## **ORIGIN**

Approved 2004/05 Capital Budget.

#### RECOMMENDATION

It is recommended that Regional Council award Tender No. 04-237, Sidewalk Renewals - East Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$222,950, plus net HST for a total of \$230,595 from Account No. CKU00558, Sidewalk Renewals, with funding authorized as per the Budget Implications section of this report.

#### **BACKGROUND**

The Approved 2004/05 Capital Budget includes funds for the replacement of concrete sidewalks because of their overall poor condition.

### **DISCUSSION**

Tenders for this project were called on May 1, 2004 and closed on May 14, 2004. The following bids, exclusive of taxes, were received:

The scope of work for this tender includes the renewal of concrete sidewalk, concrete curb and gutter and sodding at the locations listed below:

- Bolton Terrace (W), Prince Albert Road to end
- Shamrock Drive (S), Slayter Street to Victoria Road
- Vanessa Drive (N), Slayter Street to Victoria Road
- Spikenard Street (N), Valleyfield Road to Stevens Road

It is anticipated that work will commence within three weeks after award of tender.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

### **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$222,950 plus net HST, for a total of \$230,595 funding is available in the Approved 2004/05 Capital Budget under Account No. CKU00558, Sidewalk Renewals. The budget availability has been approved by Financial Services.
