



SUBJECT: APPOINTMENT OF BUILDING INSPECTORS

ORIGIN

As a requirement of the Provincial Building Code Act, all inspectors must be appointed by Regional Council.

RECOMMENDATION

It is recommended that Regional Council:

1. Appoint the staff included in Appendix "A" of this report, as Building Inspectors, pursuant to Sections 5(2) of the Nova Scotia Building Code Act. These appointments are effective for the duration of their current conditions of employment with Halifax Regional Municipality; and
2. All previous appointments as Building Inspector be hereby rescinded.

DISCUSSION

The Building Code Act of the Province of Nova Scotia requires that Building Inspectors be appointed by Regional Council. There have been several changes in staffing over the past year which require appointment. This recommendation reappoints all current Building Officials and clarifies that appointments are valid only for the duration of the conditions of employment as Building Official.


