SUBJECT: Tender No. 04-125 - Collection and Transportation of Source-

Separated Solid Waste from Condominium Properties

ORIGIN

The Halifax Regional Municipality publically advertised Tender No. 04-125 to provide services for Collection and Transportation of Source-Separated Solid Waste from Condominium Properties for the three-year period from November 1, 2004 to October 31, 2007.

RECOMMENDATION

It is recommended that:

Council award Tender No. 04-125, Collection and Transportation of Source-Separated Solid Waste from Condominium Properties for a three-year period to Enviro Waste Ltd. for the services specified in the tender, with funding (including HST) from Solid Waste Resources Operating Budget Account R322 Collection as follows:

- a) Area A Halifax/Western County at a price of \$672,556.80;
- b) Area B Dartmouth/Cole Harbour at a price of \$427,993.20; and
- c) Area C Bedford/Sackville at a price of \$181,389.96.

BACKGROUND

Halifax Regional Municipality has provided the collection of refuse, and recyclables at registered condominium properties since 1996 (and organics in 1998/99, with the introduction of composting), consistent with the service provided by former local municipalities. The current contract servicing 6,029 condominium units in the three geographic areas (Halifax/Western County, Dartmouth/Cole Harbour and Bedford/Sackville) expires October 31, 2004. Tender No. 04-125 was issued for the three-year period from November 1, 2004 to October 31, 2007.

DISCUSSION

The tenders were issued on July 24, 2004 with closure on August 12, 2004. The required services consist of the supply of collection containers as specified in the tender document, the collection of refuse, organics and recyclables at the condominiums, and the transportation of the materials in the manner, at the frequency, time and to specified receiving /processing facilities.

The price submitted is a monthly price in each Area in each year to service the condominiums as currently specified. Provision is made to add or remove condominium units (buildings) during the three-year tender period, at the unit price(s) for each service by the successful bidder. The tender total price in each area is the total price over three years for the services specified in the tender. The prices quoted for the recommended bidder for the three-year period are within 3% of current year pricing for these services.

The following bids were received in the three areas for the three-year period:
