2005 Regional Council Meeting Schedule

#### **ORIGIN**

It has been the practice for Regional Council to adopt a schedule outlining meetings of Regional Council for the forthcoming year. The proposed meeting schedule for 2005 is now before Council for consideration.

## RECOMMENDATION

It is recommended that Council adopt the 2005 Regional Council Meeting Schedule as attached.

### BACKGROUND / DISCUSSION

In accordance with Administrative Order Number 1 Section 8 (2), regular Council sessions are held every Tuesday commencing at 6:00 pm. Where there are five Tuesdays in a month, meetings are not scheduled for the fifth Tuesday. This practice is presented for Council's consideration for May and November 2005, where there are five Tuesdays, hence there is no meeting scheduled on the last Tuesday in either of these months.

It has been the practice of Council to recess during March break, four weeks during the summer and two weeks over the holiday season in December. The attached schedule proposes two three week breaks during the months of July and August, with meetings scheduled for August 2nd and 9th. The schedule reflects March 15th as March Break, July 12th, 19th, 26th, August 16th, 23 nd and 30th as summer break, and December 20th and 27th as the Holiday Season. Additionally, to provide sufficient travel time for elected officials to return from attending the Federation of Canadian Municipalities Conference and to ensure sufficient time is allocated to engage in activities surrounding the Union of Nova Scotia Municipalities Conference, meetings have not been scheduled for June 7th and October 4th, 2004.

#### Committee of the Whole

Committee of the Whole have been scheduled for the second and fourth Tuesdays each month as required.

### BUDGET IMPLICATIONS

There are no budget implications to the recommended course of action.
