## **ORIGIN**

Approved 2005/06 Capital Budget.

## **RECOMMENDATIONS:**

It is recommended that Regional Council:

- 1. approve the recovery of Local Improvement Charges for the new paving of Cherylann Drive and Astour Drive in Cow Bay by levy of frontage charges, at the rate to be established in By-Law S-418, which will be presented to Council for approval for fiscal year 2005/06.
- 2. award Tender No. 05-225, New Paving of Subdivision Streets Inside the Core Area (East Region) to Dexter Construction Company Limited for materials and services listed at the unit prices quoted for a Tender Price of \$544,868 including net HST from Capital Account No. CXU00715, New Paving of Subdivision Streets Inside the Core Area with funding authorized as per the Budget Implications of this report.

## **BACKGROUND**

The Approved Advanced Capital Budget includes funds for the paving of Cherylann Drive and Astour Drive.

#### **DISCUSSION**

Tenders were called on February 12, 2005 and closed on February 25, 2005. The following bids, exclusive of taxes were received:

The scope of work for this tender generally includes placing road gravels, shoulder gravels, paving and driveway reinstatement.

It is anticipated that work will commence when the weather permits in the Spring of 2005.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

The installation of new paving is subject to Local Improvements Charges. The proposed By-Law S-418, Respecting Charges for Street Improvements will be presented to Council for approval for fiscal year 2005/06. Staff is therefore recommending that Council approve this tender with the understanding that the LIC rates that are to be applied will be those approved by Council under By-Law S-418. In the event that By-Law S-418 is not adopted, the 2004 LIC rates will apply.

## **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$526,804 plus net HST for a total of \$544,868, funding is available in the Approved Advanced 2005/06 Capital Budget under Account No. CXU00715, New Paving of Subdivision Streets Inside the Core Area. The budget availability has been approved by Financial Services.
