





**SUBJECT:** Street Closure - Gottingen Street at Falkland Street (Parcel FS-1)

**ORIGIN**

Real Property has received a request from the owner of 2082-2086 Gottingen Street, 3093619 Nova Scotia Limited c/o Mr. Joe Arab, to close a portion of the street right-of-way at the corner of Gottingen Street and Falkland Street (Parcel FS-1) as shown on Attachment "B".

**RECOMMENDATION**

It is recommended that Council close a portion of the Gottingen Street right-of-way, Halifax, as per Administrative Order # SC-44, as shown on Attachment "B"

## **BACKGROUND**

In June, 1956, Halifax City Council moved and passed a resolution for the widening of several streets in the Gottingen, Falkland and Creighton Streets area of Halifax. It was determined under the resolution portions of Gottingen, Falkland and Creighton Streets were too narrow for adequate snow removal and that the subject streets be widened from 40 feet to 60 feet. The resolution recommended the official street lines (Blue Lines) be so altered to provide for the change of forty (40) feet to sixty (60) feet. The subject parcel (Parcel FS-1) was one of those portions.

## **DISCUSSION**

As noted above, and from the Council Minutes from 1956, the recommended street line alterations created Parcel FS-1, which is approximately 718 sq. ft., on the proponent's existing property as new road right-of-way for Falkland Street.

However, a review by staff has determined that Parcel FS-1 included in the revised street lines was never acquired by the City of Halifax and due to the recent fire which had completely destroyed the owner's previous building, the proponent seeks to redevelop the property with new residential condominiums and commercial mix building and Parcel FS-1 is required as part of that redevelopment plan.

Furthermore, since the Municipality does not own Parcel FS-1 and is part of the street right-of-way, the property owner has requested that the Municipality either acquire Parcel FS-1, or formerly close that portion of the street right-of-way. Staff have reviewed the request and has determined that Parcel FS-1 is not essential for snow clearing at the intersection of Gottingen at Falkland Street and Capital Projects has advised Real Property the asking price is too prohibitive for any proposed street improvement projects.

In October 2004, the Municipality was successful in amending the Municipal Government Act in that a Public Hearing is not required where part of a street is being altered, improved or redesigned, if:

- (a) the part of the street that remains opens
  - (i) is open to vehicular and pedestrian traffic, and
  - (ii) meets all the Municipal standards; and
- (b) the part of the street that is closed
  - (i) is determined by the engineers to be surplus;
  - (ii) is worth less than fifty thousand dollars.

**DISCUSSION CONTINUED**

It has been determined that this street closure meets all of the above noted criteria and; therefore, a public hearing is not required for the Street Closure of Parcel FS-1.

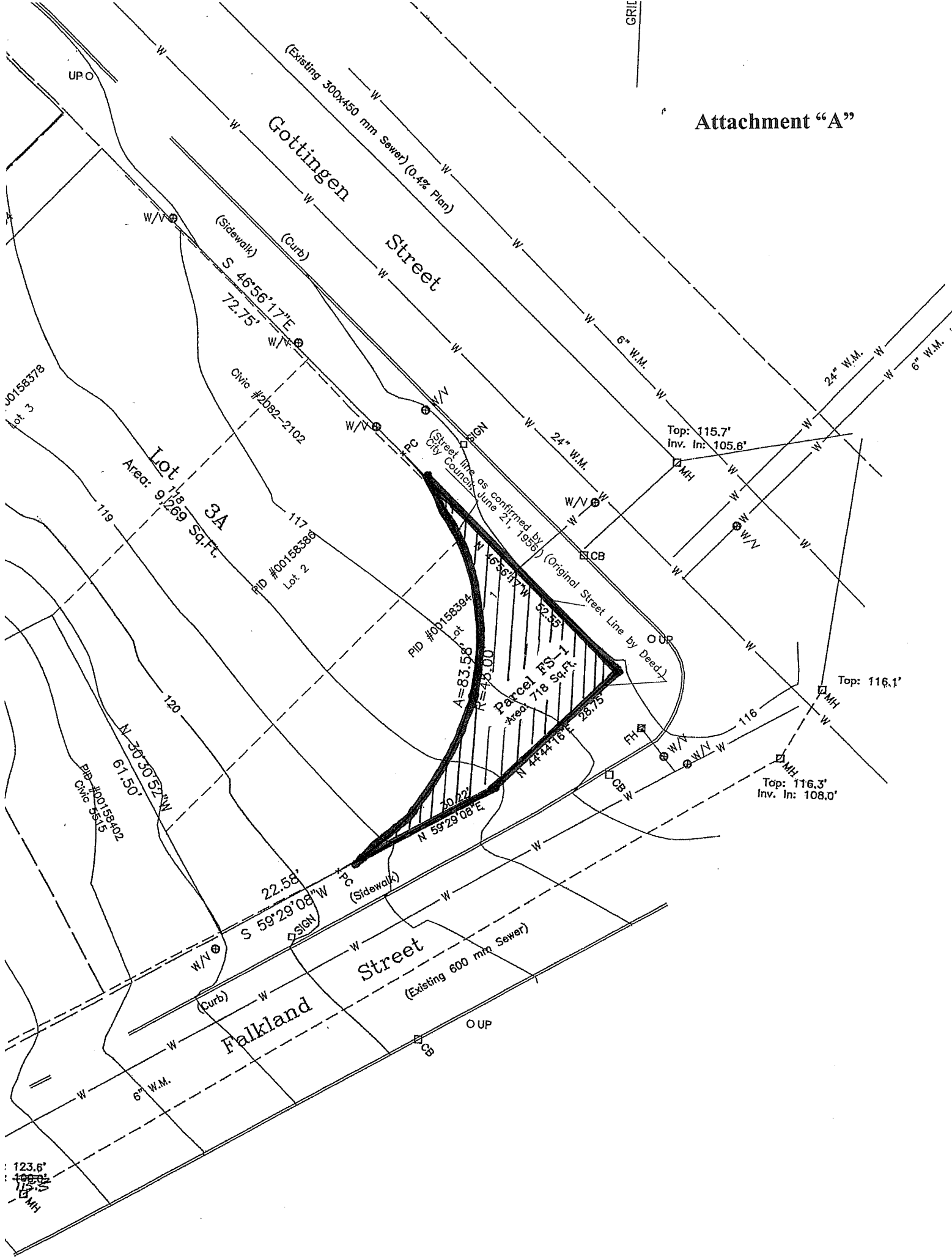
