#### INFORMATION REPORT

### **ORIGIN**

A Special Election was held in order to fill a vacancy on the Halifax Regional Council in District 8-Woodside-Eastern Passage.

## **BACKGROUND**

Due to the resignation of Councillor Kent from the Halifax Regional Council a Special Election for District 8 was called. Four candidates were nominated on November 20, 2007, to fill this vacancy. Advance Polls were held on Saturday, December 8, 2007, and Tuesday, December 11, 2007 with Saturday, December 15<sup>th</sup>, 2007 as the regular polling day.

### **DISCUSSION**

Over the three polling days there was an overall voter turn out of 10.22%. The official results of the election indicate that Jackie Barkhouse is the successful candidate for the position of Councillor for Halifax Regional Municipality District 8 - Woodside-Eastern Passage to be sworn in during the January 8<sup>th</sup>, 2008 Halifax Regional Council session.
