### **ORIGIN**

The Approved Advanced 2008/09 Capital Budget.

### RECOMMENDATION

Award Tender No. 08-203, Hillside Avenue and Highland Avenue Pavement Resurfacing, Sidewalk Renewal and Curb Renewal - West Region to Lafarge Canada Inc. for a Total Tender Price of \$384,238.73 (net HST included) with funding from Capital Accounts No. CZU01082 - Resurfacing Program, CKU01084 - Sidewalk Renewals and CYU01076 - Curb Renewals, as outlined in the Budget Implications section of this report.

### **BACKGROUND**

The Approved Advanced 2008/09 Capital Budget includes funds for the Pavement Resurfacing, Sidewalk Renewals and Curb Renewals on Hillside Avenue (Robie Street to Agricola Street) and Highland Avenue (Normandy Drive to Hillside Avenue).

## **DISCUSSION**

Tenders were called on February 6, 2008 and closed on February 20, 2008. Bids were received from the following companies:

The scope of work for this tender generally consists of the pavement resurfacing of Hillside Avenue (Robie Street to Agricola Street) and Highland Avenue (Normandy Drive to Hillside Avenue); sidewalk and curb renewal on the south side of Hillside Avenue from Robie Street to Agricola Street and on the west side of Highland Avenue from Normandy Drive to Woodbine Avenue; and curb renewal on the north side of Highland Avenue from Rosemeade Avenue continuing to Woodbine Avenue. It also includes some sewer spot repairs on both streets.

It is anticipated that construction will commence when weather permits and take four weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

# **BUDGET IMPLICATIONS**

Based on the lowest tendered price of \$384,238.73, including net HST, funding is available in the Approved Advanced 2008/09 Capital Account No. CZU01082 - Resurfacing Program, Capital Account No. CKU01084 - Sidewalk Renewals and Capital Account No. CYU01076 - Curb Renewals. The budget availability has been confirmed by Financial Services.

Tender No. 08-203, Hillside Avenue (Robie Street to Agricola Street) and Highland Avenue (Normandy Drive to Hillside Avenue), Pavement Resurfacing, Sidewalk Renewal and Curb Renewal - West Region, closed February 20, 2008. Prior to tender award, a cost sharing agreement must be finalized between HRM (Halifax Regional Municipality) and HW (Halifax Water).

In the most recent discussions on this subject, HW has agreed to pay for certain sewer upgrades. This includes the cost of replacing some existing laterals, and certain spot repairs to the existing sewer main. HW's share on this project, based on the unit prices are as follows:
