ORIGIN

The Approved 2008/09 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 08-279, Paving Renewal, Clifford Drive, East Region to Lafarge Canada Inc., for a Total Tender Price of \$458,191 (net HST included) with funding from Capital Account No. CYU01081 - Paving Renewal Program, as outlined in the Budget Implications section of this report.

BACKGROUND

The Approved 2008/09 Capital Budget includes funds for the Paving Renewal of Clifford Drive from Ellenvale Avenue to Cathy Cross Drive.

DISCUSSION

Tenders were called on August 20, 2008 and closed on August 27, 2008. Bids were received from the following companies:

The scope of work for this tender generally consists of the construction of new concrete curb and gutter to replace the existing concrete curb and gutter, removal of the existing asphalt, and reconstruction with new asphalt.

It is anticipated that work will commence within three weeks of the tender award and take four weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$458,191 (net HST included), funding is available in the Approved 2008/09 Capital Budget from Capital Account No. CYU01081 - Paving Renewal Program. The budget availability has been confirmed by Financial Services.
