#### **ORIGIN**

August 26, 2009 Heritage Advisory Committee.

### RECOMMENDATION

The Heritage Advisory Committee recommend Regional Council:

- 1. approve the sale of the registered heritage property located at 9 Spring Street, Bedford;
- 2. reduce the sale price to increase the value of HRM's in-kind contribution and the \$5,000 offered by the society be re-directed into the fabrication of an outdoor interpretation panel of a minimum value of \$5000 and to be completed within two years from the date of sale; and
- 3. schedule a public hearing.

#### BACKGROUND / DISCUSSION

At the August 26, 2009 Heritage Advisory Committee meeting, staff provided a presentation in regard to the Expression of Interest HRM issued on the property at 9 Spring Street in Bedford, known as The Teachery. The Committee endorsed the staff recommendation to approve the sale but recommended that the sale price be reduced to increase the value of HRM's in-kind contribution; and the \$5,000 offered by the society be re-directed into the fabrication of an outdoor interpretation panel (as proposed in the attached staff report, pg. 5). The interpretation panel would be of a minimum value of \$5000 and to be completed within two years from the date of sale.

### **BUDGET IMPLICATIONS**

Reducing the sale price by an additional \$5,000 to increase the value of HRM's in-kind contribution results in a total decrease of \$220,000 in the proceeds from the sale based on the market value of the property. Therefore, no proceeds will be transferred to the Sale of Land Reserve (Q101).
