<u>ORIGIN</u>

The Approved Advanced 2006/07 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 06-207, Paving Renewal, Wedgewood Avenue - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$356,008 including net HST from Capital Account No. CYU00784, Paving Renewal, with funding authorized as per the Budget Implications Section of this report.

BACKGROUND

The Approved Advanced 2006/2007 Capital Budget included funds for the paving renewal of Wedgewood Avenue from Edward Laurie Drive to Beechwood Terrace.

DISCUSSION

Tenders were called on April 22, 2006 and closed on May 5, 2006. The following bids, exclusive of taxes, were received:

1.	Ocean Contractors Limited	\$344,205
2.	Dexter Construction Company Limited	\$413,480
3.	Basin Contracting Limited	\$499,125

The scope of work for this tender generally consists of the replacement of existing asphalt curb with new concrete curb and gutter, renewing the pavement and associated reinstatement.

It is anticipated that work will commence within three weeks of the tender award and take eight weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$344,205, plus net HST for a total project cost of \$356,008, funding is available in the Approved Advanced 2006/07 Capital Budget from Capital Account No. CYU00784, Paving Renewal. The budget availability has been confirmed by Financial Services.
