ORIGIN

The Approved 2006/07 Capital Budget.

RECOMMENDATION

It is recommended that Council award Tender No. 06-222, Resurfacing and Sidewalk Renewal, Claremont Street and New Sidewalk, White Glove Terrace - West Region to Ocean Contractors Limited for materials and services listed at the unit prices quoted for a Tender Price of \$284,399 including net HST from Capital Account No. CZU00782, Resurfacing, Capital Account No. CKU00783, Sidewalk Renewal and Capital Account No. CJU00785, New Sidewalk, with funding authorized as per the Budget Implications Section of this report.

BACKGROUND

The Approved 2006/07 Capital Budget included funds for the paving resurfacing on Claremont Street from Connolly Street to Maxwell Avenue, sidewalk renewal on Claremont Street from Connolly Street to Oxford Street and for a new sidewalk on White Glove Terrace from Milsom Street to Peace Court.

DISCUSSION

Tenders were called on July 12, 2006 and closed on July 21, 2006. The following bids, exclusive of taxes, were received:

1.	Ocean Contractors Limited	\$274,970.00
2.	Lafarge Canada Inc.	\$289,700.00
3.	Dexter Construction Company Limited	\$343,300.00
4.	Basin Contracting Limited	\$351,935.00

The work generally consists of paving resurfacing, sidewalk renewal, new sidewalk, concrete curb and gutter replacement and associated reinstatement.

It is anticipated work will commence within three weeks of tender award and take eight weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with the paving resurfacing/sidewalk renewal. and there are no Local Improvement Charges associated with the installation of the new sidewalk on White Glove Terrace as there is existing sidewalk on the opposite side of the road.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$274,970, plus net HST for a total project cost of \$284,399. Funding is available in the Approved 2006/07 Capital Budget from Account Numbers CZU00782, Resurfacing, CKU00783, Sidewalk Renewal and CJU00785, New Sidewalk. The budget availability has been confirmed by Financial Services.
