SUBJECT:Award - Unit Price Tender No. 10-226, South Street (South Park Street
to Robie Street) Resurfacing and Sidewalk Renewal

ORIGIN

The Approved Advanced 2010/11 Capital Budget.

RECOMMENDATION

It is recommended that Halifax Regional Council award Tender No. 10-226, South Street (South Park Street to Robie Street) - West Region to Ocean Contractors Limited for a Total Tender Price of \$588,511.01 (net HST included) with funding from Capital Account Nos. CKU01084 - Sidewalk Renewals and CZU01082 - Resurfacing Program as outlined in the Budget Implications section of this report.

The Approved Advanced 2010/11 Capital Budget includes funds for the pavement resurfacing as well as curb and sidewalk renewal on South Street from South Park Street to Robie Street.

DISCUSSION

Tenders were called on March 26, 2010 and closed on April 14, 2010. Bids were received from the following companies:

The scope of work for this tender generally consists of the replacement of existing concrete curb and gutter with new concrete curb and gutter, replacement of existing concrete sidewalk with new concrete sidewalk on the north side from Robie Street to Tower Road, removal of the existing asphalt, installation of new asphalt and associated reinstatement.

It is anticipated that work will commence within three weeks of the tender award and take 6 weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

BUDGET IMPLICATIONS

Based on the lowest tendered price of \$588,511.01 (net HST included), funding is available in the Approved Advanced 2010/11 Capital Budget from Capital Account Nos. CKU01084 - Sidewalk Renewal, and CZU01082 - Resurfacing Program. The budget availability has been confirmed by Financial Services.
