SUBJECT: Amendments to Administrative Order Number 37 - Respecting
Commerce and Vending on Municipal Lands (Site Locations)

ORIGIN

This report brings forward amendments necessary to support ongoing delivery of the license program. There are four (4) components to this amendment; housekeeping of the existing site descriptions; removing mobile canteen sites from inside Grand Parade; removing the “non-food merchandise” restriction at one existing mobile canteen site; and adding two new and relocating three existing Newspaper Box sites.

RECOMMENDATION

It is recommended that Halifax Regional Council **approve** the amendments to Administrative Order Number 37, as described in Schedule “A” attached to this report.

BACKGROUND

Street vending in HRM is governed by By-Law C-500, Respecting Commerce and Vending on Municipal Lands. Vending, by artisans and craftspeople, food vendors, or newspaper boxes, is only permitted on designated sites which are listed in Administrative Order Number 37.

The By-Law allows for new sites to be identified by vendors, reviewed by staff and then presented to Council for potential addition to the Administrative Order. Approved locations may also become less desirable over time, therefore, HRM staff or the licence holders may request that some sites be removed from the approved list. At this time, staff has identified some areas of the Administrative Order which should be addressed.

DISCUSSION

There are four (4) components to this amendment:

1. Housekeeping of the existing site descriptions
2. Removing Mobile Canteen sites from inside Grand Parade
3. Removing the “Non-Food Merchandise” restriction at one existing Mobile Canteen site
4. Adding two new and Relocating three existing Newspaper Box sites

1. Housekeeping of the existing site descriptions

Part A, Part B, and Part D of the Administrative Order lists the approved sites for Mobile Canteens which are Motor Vehicles, all other Mobile Canteens, and Newspaper Boxes respectively. The current location descriptions in the Administrative Order are too vague; they are not measured or described consistently from one site to the next. This makes it very difficult for vendors to set up their canteens or their newspaper boxes in the approved site, and also poses a challenge for staff attempting to enforce conformance to the intended approved location.

The proposed changes to the lists in Part A, Part B, and Part D provide a clear and consistent description of the site, by always providing a measurement to the approved area from the centerline of the nearest cross street. Photos with the approved area will also be provided upon request as a supplement to the written location description. This supplemental information will be available to the Licence Administrator, licence applicants, and other HRM staff.

Part D of the Administrative Order also implies a requirement for existing newspaper box sites to have concrete pads installed under the boxes where the approved site is on the grass beside the sidewalk. Before By-Law C-500 took effect in September 2006, boxes existed on these sites without a concrete pad. Since the By-Law took effect, no new pads have been installed. As the newspaper boxes are all located adjacent to existing sidewalk, Staff is proposing to remove the note at the end of the list identifying sites requiring concrete pads.

2. Removing Mobile Canteen sites from inside Grand Parade

There are currently two (2) approved Mobile Canteen sites inside Grand Parade (Part B, sites 9 and 10). HRM staff is recommending that these locations be removed from the approved list. There are challenges in getting the mobile canteen into the Grand Parade area after hours as gates are used to block vehicles from accessing the area.

Note that one vendor currently has one year remaining on their 5-year licence at one of these locations in Grand Parade. Staff intends to allow this vendor to set up in Grand Parade at the current site when gates are open, but also allow the vendor to use a site which is currently vacant on Argyle Street (Part B, Site 8) when the gates to Grand Parade are closed. This arrangement will be valid until the vendor’s current licence expires at the end of 2010. The licence holder is agreeable with this arrangement.

3. Removing the “Non-Food Merchandise” restriction at one existing Mobile Canteen site

HRM staff is also recommending that a site near Grand Parade which is designated as a “non-food merchandise only” site (Part B, site 8) be modified to allow food vendors to bid in this site. Removing the “Non-Food Merchandise” restriction at this site would provide the current licence holder at site 9 in Grand Parade an alternative location to bid on for 2011.

4. Adding two new and Relocating three existing Newspaper Box sites

The owners of the newspaper boxes proposed ten (10) potential new locations in 2009. Staff reviewed the locations and is recommending approval of two (2) new sites, three (3) site relocations. Proposed changes to the approved of newspaper box sites are summarized below:

New Site	Oxford Street near Quinpool Rd.	The site is next to a bus stop and the Oxford Theatre. There is demand for the boxes and staff believes the location is appropriate.
New Site	224 Waverley Rd.	The site is in front of a popular coffee shop. There is demand for the boxes and staff believes the location is appropriate.
Site Relocation	Robie St., East Side, South of Cunard St.	Relocated from the West Side of Robie Street, where the previous site was in front of a house and in a congested area.
Site Relocation	Martello Rd., 10m South of Spring Garden Rd.	Relocated from 50m south of Spring Garden Rd. The demand for the boxes is closer to the bus stop on Spring Garden Rd.
Site Relocation	Barrington St. near Blowers St.	Relocated from Argyle St. at the former Herald Building, where the previous site is now in a construction area.

BUDGET IMPLICATIONS

Part B (Mobile Canteens):

Licences for Mobile Canteen sites are issued by tender. The minimum bid for a cart site like the two in Grand Parade (sites 9 and 10) is \$1,150/year, and for a non-food cart site like the one on Argyle Street (site 8) is \$600/year. The current tender bid on site 9 is \$2,250 per year, site 10 is currently vacant. By eliminating the two cart sites in Grand Parade, and removing the “non-food” status of the Argyle Street location, HRM will lose a minimum of \$1,750/year in licencing fees. Based on tender bid history the potential loss may reach \$5,000. Records indicate however that one of the Grand Parade sites and the Argyle Street site have been vacant for the last couple of years, so actual revenues from Mobile Canteen licence fees are not likely to change as a result of the proposed amendments.

Part C (Newspaper Boxes):

The changes to the list of approved sites for newspaper boxes also result in a potential gain in revenue. Each newspaper box at an approved site is subject to a licence fee of \$55/year. Actual revenues will depend on the number of newspaper publishers that purchase a licence at the new sites.

FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality’s Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation.

ALTERNATIVES

There are no recommended alternatives.




