RECOMMENDATION

It is recommended that Halifax Regional Council:

- 1. Give First Reading to the proposed amendments to the Beaver Bank, Hammonds Plains and Upper Sackville Municipal Planning Strategy and Land Use By-law as provided in Attachments C and D of the staff report dated March 11, 2011, and schedule a Public Hearing;
- 2. Approve the proposed amendments to the Beaver Bank, Hammonds Plains and Upper Sackville Municipal Planning Strategy and Land Use By-law as provided in Attachments C and D of the staff report dated March 11, 2011.

BACKGROUND

ORIGIN

North West Planning Advisory Committee meeting – April 6, 2011.

RECOMMENDATION

It is recommended that North West Planning Advisory Committee recommend that North West Community Council recommend to Regional Council:

- 1. Give First Reading to the proposed amendments to the Beaver Bank, Hammonds Plains and Upper Sackville Municipal Planning Strategy and Land Use By-law as provided in Attachments C and D of the staff report dated March 11, 2011, and schedule a Public Hearing;
- 2. Approve the proposed amendments to the Beaver Bank, Hammonds Plains and Upper Sackville Municipal Planning Strategy and Land Use By-law as provided in Attachments C and D of the staff report dated March 11, 2011.

BACKGROUND/DISCUSSION

At its meeting on April 6, the Committee reviewed the proposed application to amend the plan area boundaries so that the entire subdivision falls within the Planning Districts 1 & 3 (St. Margaret's Bay) MPS and LUB. This change would affect the northeast portion of the subdivision (refer to Appendix A and B in Attachments A through D). As a result, this portion of the subdivision would no longer fall under the jurisdiction of the North West Community Council and PAC, but would be solely under that of Western Region Community Council. If Council adopts the proposed amendments, the Planning District 1 & 3 zoning maps will be replaced with a new, consolidated version.

ALTERNATIVES

- 1. Council may choose to approve the proposed amendments to the Municipal Planning Strategies and Land Use By-laws for Planning Districts 1 and 3 and Beaver Bank, Hammonds Plains and Upper Sackville as outlined in the March 11, 2011 staff report and presented in Attachments A through D. This is the recommended alternative.
- 2. Council may choose to modify the proposed amendments to the Municipal Planning Strategies and Land Use By-laws for Planning Districts 1 and 3 and Beaver Bank, Hammonds Plains and Upper Sackville as presented in Attachments A through D. If this alternative is chosen, specific direction regarding the requested modifications and amendments is required. Substantive amendments may require another public hearing be held before approval is granted.
- 3. Council may choose to refuse the amendments to the Municipal Planning Strategies and Land Use By-laws for Planning Districts 1 and 3 and Beaver Bank, Hammonds Plains and Upper Sackville as presented in Attachments A through D. This is not the recommended course of action.
