Background

Planning Services

- In late 2007/08, residents began experiencing water quality issues
- Regional Plan Policy (SU- 14)
- Study required
- Input from CD, IAM, HW, TPW



Discussion

Planning Services

- Highlights of Consultant's Report
- Water issues coincident with const'n work in business campus
- Giles Dr. properties outside area req'd for blasting survey
- Unique geological characteristics in the area



Discussion, con't

Planning Services

- With on-going Bedford West development, continued risk of well water quality/quantity issues
- Longer term development considerations for larger area



Discussion, con't

Planning Services

Consultant Report's Conclusion:

Given proximity to piped water, past and ongoing issues, and longer term development considerations, extend Water Service Area to include existing Giles Drive properties



Discussion, con't

Planning Services

Recommended Solution:

- Installation of "interim" water laterals until larger area is fully serviced
- This addresses problem and minimizes cost to residents



Discussion, con't

Planning Services

Wastewater System Implications (Policy SU-20)

- Important to properly maintain septic systems
- Signed letters from property owners agreeing to do so



Discussion, con't

Planning Services

Funding Considerations:

- Cost of recommended solution = \$150,000
- PCAP application not successful
- HRM contribution of \$50,000 (Nov. 16/10)
- External contribution of \$50,000
- Outstanding amount = \$50,000, to be re-couped through LIC for the 5 properties (\$10,000 each)

Planning Services

Local Improvement Charge By-law

- Survey Letters to the 5 property owners (Apr/11) re. \$10,000 LIC
- Responses: 4 in favour, 1 no-response



Recommendation

Staff recommend that Regional Council:

- 1. Approve By-law L-133 (LIC) as per Attachment A of staff report;
- Approve the Project Budget in the amt. of \$150,000 (\$50,000 from West Bedford Holdings Ltd., \$50,000 from Operating Cost Ctr. M421 and remaining monies funded from LIC Bylaw L-133);
