# **ORIGIN**

Section 9(6) of the Procurement Policy requires a quarterly report to Regional Council of all awards approved by the CAO and his designate.

Under Section 9(4) of Administrative Order #35, the Procurement Policy, approved by Regional Council on June 8, 2004 and most recently amended on July 5, 2011, the CAO may approve the award of contracts where the award conforms to the Procurement Policy and does not exceed \$50,000 for sole/single source, \$500,000 for RFQ's, tenders and RFP's where the funds and programs have been approved by Regional Council as part of the annual business planning and budget process, and the expenditure will not result in an over-expenditure of the entire budget.

Under Section 9(5) of the Procurement Policy, the Interim Award provision, the CAO may approve the award of contracts during the summer months and December Holiday break periods, for RFQ's, tenders and RFP's where the award conforms to the Procurement Policy, and funds have been approved by Regional Council and the expenditure will not result in an over-expenditure of the entire budget.

The purpose of this report is to provide a listing of those contracts which were approved by the CAO during the period July 1, 2011 to September 30, 2011.

# **BACKGROUND/DISCUSSION**

Section 9(6) of the Procurement Policy requires a quarterly report to Regional Council of all awards approved by the CAO or his designate. As per this requirement, the data for awarded contracts by the CAO for the period July 1, 2011 to September 30, 2011 have been summarized in the attached tables.
