BACKGROUND

Following the release of the Coastal Management Framework in 2008, and the State of Nova Scotia's Coast Report in December 2009, the Provincial Oceans Network (PON), an umbrella group representing fifteen departments and agencies, conducted extensive research and public consultations about coastal management in Nova Scotia.

A draft Coastal Strategy (http://www.gov.ns.ca/coast/) has been completed and is now being circulated for feedback.

DISCUSSION

The strategy focuses on seven key issues:

- 1. Coastal Development
- 2. Working waterfronts
- 3. Public coastal access
- 4. Sea level rise and storm events
- 5. Coastal ecosystems and habitats
- 6. Coastal water quality
- 7. Governance

The objectives and actions complement and integrate well with the HRM Municipal Planning Strategy.

HRM staff recommends that this strategy is a sound piece to facilitate an integrated planning and management approach to coastal issues.

BUDGET IMPLICATIONS

This Strategy has no implications on the 2011/2012 Budgets. Further, the strategy offers no specific implications to future budgets. However, sound planning and coastal management over time will reduce long term municipal service delivery and infrastructure costs.
