SUBJECT:	Request for Comprehensive Review of Halifax Metro Centre Operations

<u>ORIGIN</u>

July 18, 2012 Audit and Finance Standing Committee meeting and presentation given by Mr. Larry Munroe, Auditor General, on the review of the transfer of box office operations from the Halifax Metro Centre to Trade Centre Limited.

RECOMMENDATION

It is recommended that Halifax Regional Council authorize staff to:

- 1. Undertake a comprehensive review of the operations of the Halifax Metro Centre, including a specific review of the box office operations, the commission structure and the cost allocation process in place.
- 2. Issue and award an RFP for portions of this work as necessary.
- 3. Carry out this review, and any necessary follow-up, under the direction of HRM's Chief Financial Officer with quarterly updates provided to the Audit and Finance Standing Committee.

BACKGROUND

As outlined in the recently published report prepared by the Office of the Auditor General, the issue regarding the transfer of box office operations (Metro Centre Box Office/Ticket Atlantic) from the Halifax Metro Centre to Trade Centre Limited was raised in a previously released report entitled "A Review of Concerts Held on the North Common - January 2006 to March 2011". Information identified in that report resulted in a further review of the transfer and the preparation and release of the current report entitled "Review of the Transfer of Box Office Operations from the Halifax Metro Centre to Trade Centre Limited". DISCUSSION

Mr. Larry Munroe, Municipal Auditor General, presented his report entitled "Review of the Transfer of Box Office Operations from the Halifax Metro Centre to Trade Centre Limited" to the Audit and Finance Standing Committee on July 18, 2012. Following the presentation by the Auditor General, the Committee passed the motion requesting a comprehensive review of the operations of the Halifax Metro Centre, including a specific review of the box office operations, the commission structure and the cost allocation process in place. The Audit and Finance Standing Committee recommends that Halifax Regional Council approve authorization for staff to take action on the requested comprehensive review as outlined in the recommendations.

BUDGET IMPLICATIONS

The estimated cost of the review is anticipated to be in the \$50,000 range and will be funded through operation savings achieved in 2012/13.
