SUBJECT: Street Closure – Portion of Marilyn Drive Right-of-Way, Dartmouth

ORIGIN

An unsolicited request from Ellen Kelly expressing an interest in acquiring a portion of the Marilyn Drive right-of-way, more particularly described as a portion of PID No. 40937716 to be used as a private garden.

RECOMMENDATION

It is recommended that Halifax Regional Council:

1. Approve the closure of a portion of the Marilyn Drive right-of-way, as shown on Attachment "B", to facilitate the market disposal of the property to Ellen Kelly.

BACKGROUND

Approval Authority:

As per section 325 of the HRM Charter, Council may, by policy, permanently close any street or part of a street. The portion of the street that is being closed is valued less than fifty thousand dollars (\$50,000), therefore, no public hearing is required.

Marilyn Drive is a residential street located off of Portland Street, Dartmouth. The site was retained for the purpose of a roadway from Marilyn Drive to Green Village Lane. With the development of Green Village Lane, the connection was minimized to maximize the number of single family homes that could be built along Green Village Lane. A portion of the site remains and is used as a pedestrian connection for the two roads.

HRM was approached by the adjacent owner to sell a portion of the lands. The property was processed through the internal real property review and there was no municipal need determined for the site. HRM will be retaining the walkway between the two road ways; however, HRM staff is recommending the surplus and closure of a portion of the underutilised right of way, as there will not be a future street connection between Marilyn Drive and Green Village Lane.

DISCUSSION

The closure of the subject parcel will facilitate the sale of lands which will be the subject of an approval report under the delegated approval authority of the Director of Planning & Infrastructure, as per the terms and conditions detailed within the private and confidential information report dated July 12, 2012.

As per the zoning, within the Dartmouth Land Use By-Law, the additional land will not increase development potential for the adjacent owner's property. The land will solely provide additional space for a garden for the existing single family home, unless the owner was to pursue a development agreement for the parcel.
