# BARRINGTON STREET Heritage Conservation District HERITAGE INCENTIVES

### **Program Overview**

#### Development Approvals

- The Barrington Street Heritage Conservation District Incentive Program came into effect 2009 as a 5 Year Program (2009 2013).
- The program is a combination of Grants & Tax Credits, and eligible work includes both exterior restoration and base building improvements.

### **Program Terms**

#### **Development Approvals**

- Grants (maximum \$100,000) for 50% of exterior restoration costs up to \$200,000.
- Tax Credit for 15% of exterior restoration costs over \$200,000.
- Tax Credit for 15% of interior renovation costs.
- Tax Credit for 15% of cost of exterior building envelope on approved additions.
- Waiver of Building Permit fees.

### Eligible Work

#### **Development Approvals**

#### **INTERIOR**

- Code and fire safety upgrades.
- Renovation of common areas lobbies, hallways, stairs, washrooms, elevators.
- Renovation of central building systems - HVAC, plumbing, electrical, sprinklers, etc.
- Energy efficiency improvements

### **EXTERIOR**

- Storefronts
- Upper facades
- · Exterior walls
- · Windows & doors
- Roofs & chimneys
- Foundations
- Signs
- Awnings

### **Program Conditions**

### **Development Approvals**

- Completion within fiscal year of approval except by agreement for carry-over.
- Completion of work to applicable standards, inspection by HRM staff, and submission of receipts and paid invoices.
- Agreement to maintain and not apply for demolition for 20 years.

**Project:** Storefront replacement with traditional design (including painting and new signage), upgrade to interior common stairwell, masonry repairs, roof repairs, replacement of rear windows, electrical and HVAC upgrades,

# Nova Scotia Furnishings Building

Value of eligible work: \$178,488


Grant request: \$89,244

Tax Credit request: \$0

**Project:** Masonry restoration on all 4 building sides, replace exterior lighting, restore Argyle & Barrington Street storefronts (including decorative steel), replace 3<sup>rd</sup> floor windows (Argyle side).

### Buckley's Building

### **Development Approvals**



Value of eligible work: \$158,850

Grant request: \$5,925

Tax Credit request: \$22,050

**Project:** Install sprinkler & HVAC systems, exterior painting & replace exterior knee wall panels, common area upgrades to flooring & painting, repair to demising walls, upgrades to pluming & electrical in residential units, new interior doors.

# Mary McApline Building

Value of eligible work: \$151,480

Grant request: \$62,170

Tax Credit request: \$4,071

**Project:** storefront restoration including stained glass transoms, custom iron work for parapet, roof insulation and repair, skylight replacement, and upgrades to sprinkler system.
