SUBJECT:

Council Appointments to various Boards & Committees

ORIGIN

The requirement to fill vacancies on various Boards & Committees (internal to HRM & external to HRM) on which Members of Halifax Regional Council are required to sit.

RECOMMENDATION

It is recommended that Halifax Regional Council;

- 1) Refer the nominations for Council representatives on the following committees to the respective Standing Committees for nomination to Regional Council, as provided for in the Terms of Reference of the Standing Committees, to fill the vacancies no later than the 1st meeting of Regional Council in January 2013.
 - a. Council representatives on the Halifax- Dartmouth Bridge Commission, Canadian Urban Transit Association and the Active Transportation Standing Committee to the Transportation Standing Committee for nomination
 - b. Council Representatives on the Halifax Regional Water Commission to the Environment & Sustainability Standing Committee for nomination
 - c. Council representatives on the Grants and Special Events Advisory Committees to the Audit & Finance Standing Committee for nomination
- 2) Proceed to fill the vacancies for Council representatives on the Destination Marketing Board, Neptune Theatre Board, FCM and Trade Centre by way of secret ballot for the terms as outlined in Attachment 1 of this report.

Council Report

BACKGROUND/DISCUSSION

Standing Committee Nominations

On November 20, 2012 Halifax Regional Council appointed members of Regional Council to the vacancies on Standing Committees of Council thereby empowering the Standing Committees to commence the business of the Committees. Based on the Terms of Reference of the Standing Committees, as approved by Regional Council, each Committee has the mandate to be the nominating body (to Regional Council) for the members of a number of Boards and Committees.

This report recommends that the Standing Committees be tasked by Regional Council to bring back to Regional Council the nominations of members of Council for the committees for which they have nominating authority no later than the 1st Regional Council meeting in January 2013.

Selection by Ballot

There are a number of Boards & Committees which need to be filled expeditiously and, due to the interest expressed by members of Council, require that Council move to fill the vacancies by way of ballot. Where a number of nominations have been put forward the general practice of Council is to 1) consider which Councillors have served previously on the Board or Committee and provide opportunity for new Councillors to serve 2) consider the geographic and urban/suburban/rural representation of the Board or Committee and 3) make their selections by way of secret ballot.

The recommendation of this report is that Council proceeds to fill the vacancies on Destination Marketing Board, Neptune Theatre Board, Federation of Canadian Municipalities (FCM) and Trade Centre in this manner.

FCM Appointment

In 2011 the Bylaws of the Federation of Canadian Municipalities (FCM) were changed to enable HRM to put forward the nomination for one of the four Nova Scotia Board members directly to FCM.

In 2012 Council appointed Councillor Sue Uteck to the Board for a two (2) year term to June 2014. As Councillor Uteck was not re-elected HRM's position on the Board of Directors of FCM is currently vacant.

The Federation of Canadian Municipalities (FCM) is the national body advancing the interests of municipalities across Canada. FCM has the mandate to act as official spokesperson for Canadian cities, towns and municipal authorities on all municipal matters to the Government of Canada. As such it is imperative that the representative to the Board of FCM have a strong voice regarding the interest of the Region and in representing HRM's interests on the national stage.

Attachment 2 – Proposed FCM Resolution

Whereas the Federation of Canadian Municipalities (FCM) represents the interests of municipalities on policy and program matters that fall within federal jurisdiction;

Whereas FCM's Board of Directors is comprised of elected municipal officials from all regions and sizes of communities to for a broad base of support and provide FCM with the prestige required to carry the municipal message to the federal government; and

Whereas in accordance with bylaw No. 1 of the Federation Canadian Municipalities, one of the Directors representing Nova Scotia shall be appointed by the Halifax Regional Municipality; and

Whereas the HRM Director's position is currently vacant;

Be it resolved that the Council of the Halifax Regional Municipality appoints Councillor (INSERT) to the represent HRM on the Board of Directors of FCM for a term to June 2014; and

Be it further resolved that Council assume all costs associated with Councillor (INSERT) attending FCM's Board of Directors meetings.
