### <u>ORIGIN</u>

Resolution of the Executive Standing Committee dated October 28, 2013.

### **ORIGIN**

It has been the practice for Regional Council to adopt a schedule outlining meetings of Regional Council for the forthcoming year.

# **LEGISLATIVE AUTHORITY**

The mandate of the Executive Standing Committee, as adopted by Regional Council is to fulfil the self-governance role of Regional Council including:

3.6 General Council Governance

3.6.1 The Executive Standing Committee shall act as a review committee for matters related to the general self-governance and administration of Council as directed by Council.

# RECOMMENDATION

It is recommended that the Executive Standing Committee review scheduling options and put forward a recommendation to Regional Council in regard to the 2014 Regional Council schedule.

# **BACKGROUND**

In accordance with Administrative Order One, Section 8(2), regular Council sessions are held on Tuesdays at an hour deemed appropriate by the Mayor and the Chief Administrative Officer jointly. Regularly scheduled meetings of Regional Council may be canceled with the agreement of the Mayor/CAO or may be added with appropriate notice provided in accordance with the HRM Charter.

### **DISCUSSION**

Since amalgamation Halifax Regional Council has adopted a Regional Council meeting schedule for the coming year. This process allows members of Council, staff and members of the public to be notified and plan in advance for Regional Council meetings.

Traditionally Halifax Regional Council has adopted a modified weekly meeting which combined a schedule for both Committee of the Whole and Regional Council.

Regional Council adopted a Standing Committee structure in December 2011. A number of matters are now initiated and/or addressed in Standing Committees prior to coming to Regional Council. This change in process has contributed to more streamlined agendas for Regional Council.

Following the 2012 Municipal Elections, Council moved from six (6) to three (3) Community Councils covering much larger geographic areas. Several Community Councils have a substantial number of planning and community matters to be dealt with at Community Councils which has resulted in additional meeting requirements.

Significant time commitment is required of members of Council in preparation and attendance at Community Councils, Standing Committees and other Boards & Committees of Council. Recommendations in regard to these changes will be addressed further by the Executive Committee through the governance review process currently underway.

# FINANCIAL IMPLICATIONS

There are no budget implications associated with the recommended course of action.
