HALIFAX REGIONAL MUNICIPALITY BARRINGTON STREET HERITAGE CONSERVATION DISTRICT REVITALIZATION PLAN

BE IT ENACTED by the Council of the Halifax Regional Municipality that the Barrington Street Heritage Conservation District Revitalization Plan is further amended as follows:

- 1. Section 4.2 is amended by:
 - (a) striking out the words "Heritage Building" in the header after the number 4.2 and before the word "Conservation"; and
 - (b) striking out the first paragraph after the number "4.2." and before the word and number "Policy 4"; and
 - (c) adding the following sentence after the number 4.2 and before the word and number "Policy 4" as follows:

In 2014, as part of the revised Regional Plan, HRM adopted the Standards & Guidelines for the Conservation of Historic Places in Canada, 2nd Edition in place of its earlier Heritage Building Conservation Standards.

- 2. Policy 4 is amended by:
 - (a) striking out the words "as Guide" after the words "Standards" and before the words "for Issuance" in the header of the Policy;
 - (b) striking out the words "HRM Heritage Building Conservation" after the word "The" and before the word "Standards";
 - (c) adding the words "for the Conservation of Historic Places in Canada, 2nd Edition" after the word "Standards" and before the word "shall" in Policy 4; and
 - (d) striking out the words and period "provide the primary frame of reference by which applications for Certificates of Appropriateness shall be evaluated." after the words "and shall"; and
 - (e) adding the following words and sentence after the struck word "evaluated" in Policy 4:

be used to evaluate any proposed alteration to any property within the district. The Guidelines for the Conservation of Historic Places in Canada, 2nd Edition shall be used to interpret and apply these Standards.

- 3. Section 4.4 is amended by:
 - (a) striking out the word "one" after the word "until" and before the word "year" in clause b of Policy 10;
 - (b) adding the word "three" after the word "until" and before the word "year" in clause b of Policy 10;
 - (c) striking out the word "has" after the word "year" and before the word "elapsed" in clause b of Policy 10;

- (d) adding the word "have" after the word "year" and before the word "elapsed" in clause b;
- (e) adding the letter "s" to the word "year" in clause b of Policy 10;
- (f) striking out the word "one" after the words "During the" and before the word "year" in clause c of Policy 10; and
- (h) adding the word "three" after the words "During the" and before the word "year" in clause c of Policy 10.
- 4. Policy 18 of section 8.1 is amended by:
 - (a) striking out the word "one" after the word "after" and before the word "year";
 - (b) adding the word "three" after the word "after" and before the word "year"; and
 - (c) adding an "s" to the word "year".
