SUBJECT:

Appointment – Board of the Federation of Canadian Municipalities (FCM)

ORIGIN

Requirement for Regional Council to authorize HRM Regional Council's nomination to the Board of Directors of the Federation of Canadian Municipalities.

LEGISLATIVE AUTHORITY

Bylaws No. 1 of the Federation of Canadian Municipalities.

Section 3.2.1 Terms of Reference of the Executive Standing Committee which directs the Committee to act as the nominating body to Regional Council on Committees not otherwise delegated to other Standing Committees.

RECOMMENDATION

It is recommended that Halifax Regional Council appoint Councillor Bill Karsten as Halifax Regional Council's representative to the Federation of Canadian Municipalities (FCM) Board of Directors for a term from June 2014 to June 2016.

And, adopt the resolution required by FCM in regard to the appointment as provided in Attachment 1 of this report.

BACKGROUND

The bylaws of FCM were amended at the Annual General Meeting in Halifax in 2011 to specify that, of the four (4) Directors representing Nova Scotia on the Board of FCM, one (1) would be appointed by its Affiliate Members (UNSM) being its president, one (1) would be appointed by the Halifax Regional Municipality and the other two (2) Directors would be elected from Accredited Representative Municipal Members (at the AGM annually).

Following the Municipal Election and by resolution of Halifax Regional Council, Councillor Karsten was appointed in December 2012 to fill the unexpired term of Sue Uteck on the Board of FCM (Term from December 2012 to June 2014).

DISCUSSION

As is practice, the Clerk's Office put forward an Expression of Interest on April 8th to all members of Regional Council in regard to serving on the Board of FCM.

At the Executive Standing Committee meeting of April 28, 2014 the Committee duly nominated Councillor Karsten to serve as Halifax Regional Council's representative to the Federation of Canadian Municipalities Board of Directors for a term from June 2014 to June 2016.
