SUBJECT: Award Tender No. 14-049 Snow Removal and Ice Control, Groups A and B

ORIGIN

This report originates with the requirement for Facilities Management and Fire and Emergency Services to contract snow removal and ice control services for location Groups A & B.

LEGISLATIVE AUTHORITY

Under the HRM Charter, Section 79, Halifax Regional Council may expend money for municipal purposes. Administrative Order #35, the Procurement Policy, requires Council to approve the award of contracts for sole sources exceeding \$50,000 or \$500,000 for tenders and RFP's. See Charter Sections 79(1) and 322(3).

RECOMMENDATION

It is recommended that Halifax Regional Council award Tender No.14-049, Snow Removal and Ice Control, Groups A and B, to the lowest bidder meeting specifications, Teak Tree Enterprises Limited, for the amount of 597,402.35 (net HST included) for a three-year period, 2014 through 2017, and two additional option years with funding from Operating Accounts W200 totalling \$533,110.03 (net HST incl.) and Operating Account F160 totalling \$64,292.32 (net HST incl.), as outlined in the Financial Implications section of this report.

BACKGROUND

Tender No. 14-049 – Snow Removal and Ice Control the above-noted locations are for a 3-year period with an option to renew for two (2) additional one-year terms.

Note: Contract period runs from November 15 to April 15 of each year beginning November 15, 2014.
