SUBJECT: **Proposed By-law S-439, an Amendment to By-law S-400 Respecting Charges for Street Improvements**

ORIGIN

A by-law is required in order to recover local improvement charges for the paving of HRM owned gravel roads pursuant to By-law S-400 and the Local Improvement Policy – 1997.

LEGISLATIVE AUTHORITY

Section 104 of the *Halifax Regional Municipality Charter* allows Council to make “by-laws imposing, fixing and providing methods of enforcing payment of charges for by-laws... laying out, opening, constructing, repairing, improving and maintaining streets, curbs, sidewalks, gutters, bridges, culverts and retaining walls....”.

The following report conforms to the above Policy and *HRM Charter*.

RECOMMENDATION

It is recommended that Halifax Regional Council,

1. Approve the 2013 Local Improvement Charges as outlined on the attached By-law S-439; and,
2. Adopt By-law S-439, amending By-law S-400, the *Street Improvement By-law*, as set out in Attachment 1.

BACKGROUND

By-law S-400, the *Street Improvement Bylaw*, deals with the recovery of costs where Council undertakes a project to construct new street paving, new sidewalks, and new concrete curb and gutter. This by-law provides the authority to impose a levy on property owners as described in By-law S-400 and the local improvement policy.

DISCUSSION

Local Improvement Charges (LIC) apply for gravel road paving as per By-law S-400 and HRM Local Improvement Policy 1997. As per the process, staff reviewed construction costs of the paving of gravel roads from the 2013/14 capital program (Haley Lane and Robert Lane – refer to attached maps) , and as a result have determined the charges for 2013 as outlined in attached Schedule A and By-law S-439 of this report. The proposed By-law S-439, Respecting Charges for Street Improvements, is an amendment of By-law S-400, the *Street Improvement By-law*, and will enable HRM to charge LICs for the paving of gravel road projects. As a note pursuant to Administrative Order 32 a public hearing is not required on the enactment or amendment of a Bylaw unless specifically directed by Council.

FINANCIAL IMPLICATIONS

Upon Council's approval of By-law S-439, the Local Improvement Charges for the applicable 2013/14 capital projects will be levied to the relevant property owners. By ensuring that the charges reflect the actual cost of the projects, the revenue collected will offset the cost of the projects so that there is no net impact on the Approved Operating and Project Budgets.

COMMUNITY ENGAGEMENT

Hayley Lane, Beaver Bank - successfully surveyed for paving, residents were notified in writing of the survey results (refer to attached letter).

Robert Lane, Westphal - successfully surveyed for paving, residents were notified in writing of the survey results (refer to attached letter).

Not Applicable

ALTERNATIVES

Council may choose not to adopt the new charges for 2013/14; however, staff does not recommend this alternative as the previous rates would not represent the appropriate level of cost recovery.

BY-LAW NUMBER S-439

RESPECTING CHARGES FOR STREET IMPROVEMENTS

BE IT ENACTED by the Council of the Halifax Regional Municipality that By-Law Number S-400, The *Street Improvement By-Law*, is hereby further amended as follows:

1. Schedule "A" of By-Law Number S-400 is amended by adding the following:

For all projects approved and completed between January 1, 2013 to December 31, 2013, the charges shall be as follows:

For **new** asphalt paving on Hayley Lane and Robert Lane, the charge per foot of frontage to be applied to both sides of the street shall be \$41.23 plus \$2.06 for engineering fees plus \$0.39 for bridge financing for a total charge of \$43.68.

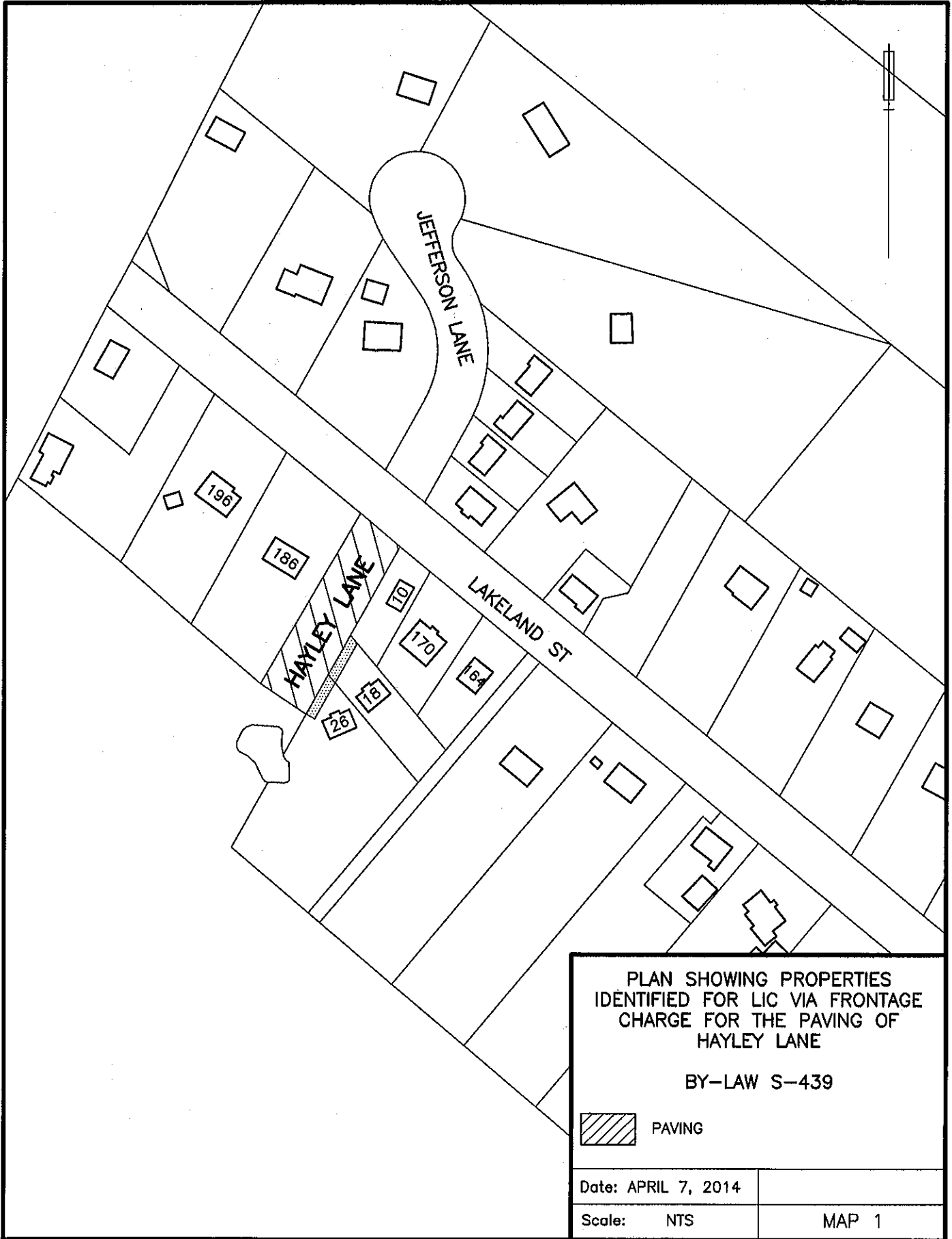

HAYLEY LANE

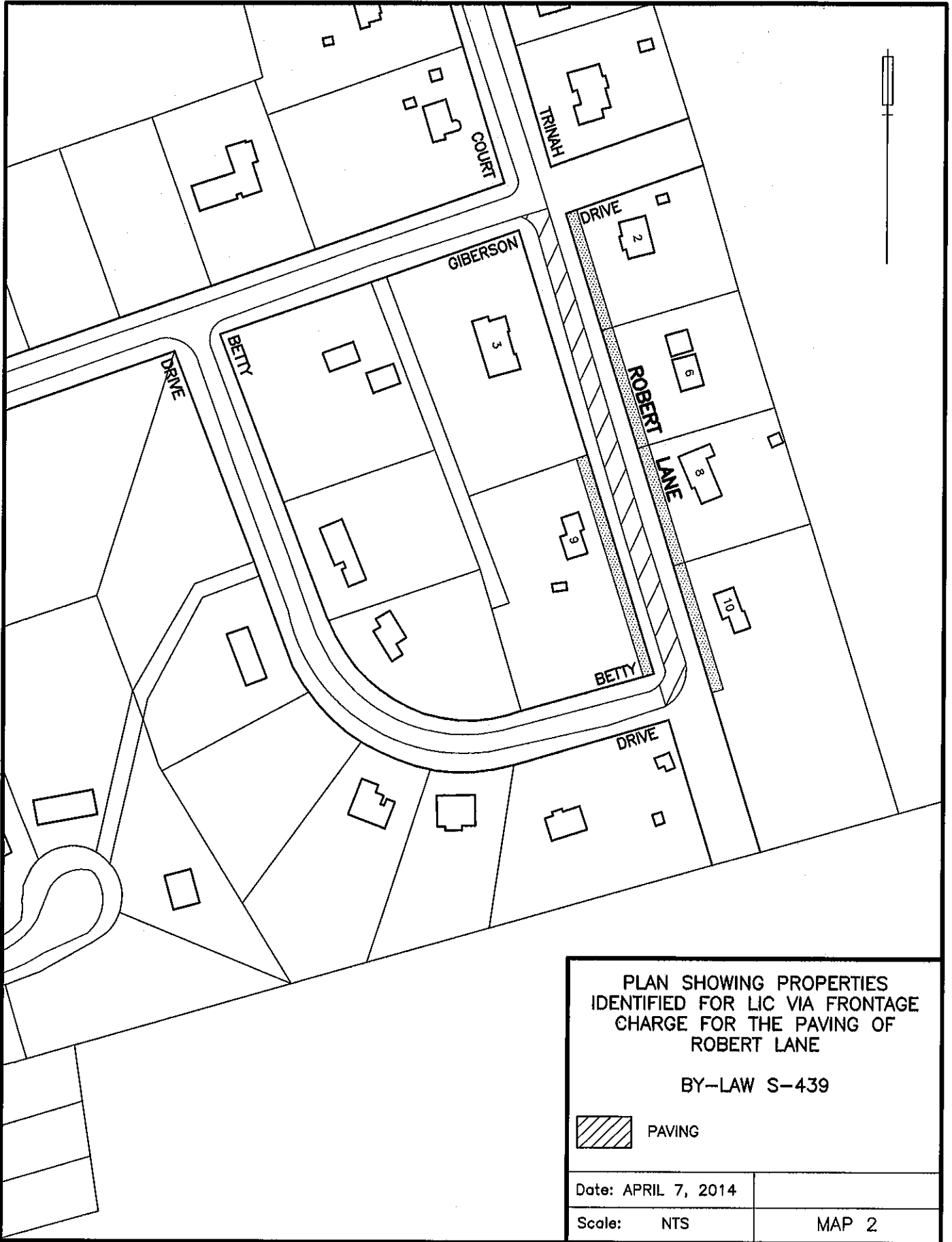

In order to facilitate the development of a list of paving projects for future Capital Budget consideration, we are attaching a survey for your review.

The purpose of this survey is to ascertain if there is sufficient support from property owners regarding the proposed paving of Hayley Lane. If Regional Council approves this project, paving will be subjected to Local Improvement Charges (LIC) as stated in By-Law Number S-400. Under this bylaw the property owners are responsible for paying 50% of the total construction costs and HRM pays for the remaining 50% of costs. Each year the LIC is determined and presented to Regional Council for their approval. The rate is determined on an annual basis and is subject to change. For the purpose of this survey an interim rate of \$40 per linear foot of property frontage is being used. If the paving is approved Hayley Lane will be submitted for consideration in the 2013/14 HRM Capital Budget.

Final billings for all Local Improvement Projects are payable over a 10 year period, with the first installment due 30 days after the billing date. Installments are due on the anniversary date of the original billing. This billing may also be paid in full at any time if the abutter so desires. The unpaid balance is subject to an interest charge at the rate of 2% above the Municipality's Bankers Prime Rate of Interest at the time the project is approved by Halifax Regional Council.

Your street has met the required 50% approval. Hayley Lane will be added to the list of successfully surveyed streets and submitted for consideration in the 2013/14 Capital Budget.

The Local Improvement Charge amount payable may, at the option of the owner of the property, be paid in equal annual installments for a period not exceeding ten years.
