Locations

<u>ORIGIN</u>

The Approved Advanced 2015/16 Project Budget as per the Council approved policy of September 16, 2008 regarding advanced funding of capital projects.

LEGISLATIVE AUTHORITY

Under the HRM Charter, Section 79 Halifax Regional Council may expend money for municipal purposes. Administrative Order #35, the Procurement Policy, requires Council to approve the award of contracts for sole sources exceeding \$50,000 or \$500,000 for RFP's and tenders respectively.

RECOMMENDATION

It is recommended that Halifax Regional Council award Tender No. 15-211, Street Planer Patching, Various Locations, to the lowest bidder meeting specifications, ARCP - Atlantic Road Construction & Paving Ltd. for a Total Tender Price of \$1,186,461.82 (net HST included) with funding from Project Account No. CR000005 – Street Recapitalization, as outlined in the Financial Implications section of this report.

BACKGROUND

The Approved Advanced 2015/16 Project Budget includes funds for Street Planer Patching of various streets throughout HRM.

DISCUSSION

Tender # 15-211 was publicly advertised on the Province of Nova Scotia's Procurement website on February 9, 2015 and closed on February 25, 2015. Bids were received from the following companies:

FINANCIAL IMPLICATIONS

Based on the lowest tendered price of \$1,137,700.00 plus net HST of \$48,761.82, for a net total of \$1,186,461.82, funding is available in the Approved Advanced 2015/16 Project Budget from Project Account No. CR000005 – Street Recapitalization. The budget availability has been confirmed by Finance.
