### ORIGIN

Motion approved at the May 14, 2015, meeting of Harbour East-Marine Drive Community Council.

## LEGISLATIVE AUTHORITY

The Halifax Regional Municipality Charter sets out the powers and duties of a community council to include

25(e) making recommendations to the Council respecting any matter intended to improve conditions in the community

#### RECOMMENDATION

That Halifax Regional Council request a staff report, the purpose of which would be to provide a status update and go forward plan of action in regard to the Shearwater / Mount Hope Connector Road.

## BACKGROUND/DISCUSSION

On May 14, 2015, Harbour East-Marine Drive Community Council approved a motion recommending that Halifax Regional Council request a staff report, the purpose of which would be to provide a status update and go forward plan of action in regard to the Shearwater/Mount Hope Connector Road.

The Shearwater/Mount Hope Connector Road was identified as a Regional Council priority outcome in December 2012, however; the Department of National Defence (DND) have re-acquired those lands from Canada Lands. The June 13, 2013 Draft Regional Plan +5 document outlined on page 3 of the Phase 111 Response to Public Input states that: "Shearwater Connector (Mount Hope Extension) is in the Plan. Integration with planning of the Shearwater DND Air Force Base will limit how quickly this can be implemented. A Growth Centre is identified in the Plan, but is reliant on the road."

As the Road Network Functional plan is under the jurisdiction of the Regional Council the Harbour East Marine Drive Community Council requests that Regional Council address the motion as passed by Community Council.
