ORIGIN

Motion from the November 2, 2015 Executive Standing Committee Meeting.

LEGISLATIVE AUTHORITY

Section 8 of the Terms of Reference of the Executive Standing Committee which directs the Committee to act as a review committee for matters related to the general self-government and administration of the Council as directed by the Council.

RECOMMENDATION

The Executive Standing Committee recommends that Regional Council accept the amended 2016 Halifax Regional Council meeting schedule as set out in Attachment 1 of this report.

BACKGROUND

It has been the practice for Regional Council to adopt a schedule outlining meetings of Regional Council for the forthcoming year. A report dated August 6, 2015 was before the Executive Standing Committee at the November 2, 2015 meeting with a draft schedule for the Committee's consideration and direction. For more information, see the background and discussion sections of the August 6, 2015 report provided in Attachment 3.

DISCUSSION

At the November 2, 2015 meeting of the Executive Standing Committee, members discussed the 2016 Council meeting schedule. The Committee determined to amend the draft schedule such that:

- The meeting on February 9, 2016 be changed to February 16, 2016 to avoid a possible scheduling conflict with the Federation of Canadian Municipalities Sustainability Communities Conference.
- A meeting be added to the schedule on July 19, 2015, and
- A meeting be added to the schedule on December 13, 2015.

The 2016 Council meeting schedule, as amended and recommended by the Executive Standing Committee, is provided as Attachment 1 of this report.

During discussion it was also requested that Committee of the Whole and Budget meetings be referenced on the schedule (provided as Attachment 2) and that all meetings of Regional Council be scheduled to commence at 10am with final meeting time to be confirmed at the approval of the agenda.

The Executive Standing Committee is comprised of seven duly elected officials. Meetings are held in public unless otherwise indicated and the agenda and materials are posted to the HRM website.

ORIGIN

It has been the practice for Regional Council to adopt a schedule outlining meetings of Regional Council for the forthcoming year.

LEGISLATIVE AUTHORITY

The mandate of the Executive Standing Committee, as adopted by Regional Council is to fulfil the self-governance role of Regional Council including:

3.6 General Council Governance

3.6.1 The Executive Standing Committee shall act as a review committee for matters related to the general self-governance and administration of Council as directed by Council.

RECOMMENDATION

It is recommended that the Executive Standing Committee review scheduling options and put forward a recommendation to Regional Council in regard to the proposed 2016 Regional Council meeting schedule.

BACKGROUND

In accordance with Administrative Order One, Section 8(2), regular Council sessions are held on Tuesdays at an hour deemed appropriate by the Mayor and the Chief Administrative Officer (CAO) jointly. Regularly scheduled meetings of Regional Council may be cancelled with the agreement of the Mayor/CAO or may be added with appropriate notice provided in accordance with the HRM Charter.

DISCUSSION

Since amalgamation Regional Council has adopted a meeting schedule for the coming year. This process allows members of Council, staff and the public to be notified and plan in advance for Regional Council meetings.

Since 2014, Regional Council has adopted a modified bi-weekly meeting schedule for Regional Council meetings.

The modified bi-weekly schedule provided as Attachment 1 of this report, proposes twenty-three (23) regular meetings and takes into account statutory holidays, March Break, meetings of Federation of Canadian Municipalities (FCM), Union of Nova Scotia Municipalities (UNSM), and the number of meetings provided for in 2015. The Executive Committee is free to recommend or adjust the proposed schedule.

FINANCIAL IMPLICATIONS

There are no budget implications associated with the recommended course of action.

COMMUNITY ENGAGEMENT

The 2016 meeting schedule for Halifax Regional Council, once adopted, is posted online at Halifax.ca to enable members of the public and media to have access to the meeting schedule, agendas and reports the Friday prior to the Regional Council meeting.

ENVIRONMENTAL IMPLICATIONS

There are no environmental implications associated with the recommended course of action.

<u>ALTERNATIVES</u>

The Executive Committee may adopt and/or adjust the proposed 2016 Regional Council meeting schedule as they see fit for recommendation to Halifax Regional Council.
