Item Title: Winter Service Standards for Streets and Sidewalks

Amendments to Part 1

- a) *Reassessment of priority 2 streets with a slope greater than 10%, low lying natural streams or other circumstances which create public safety concerns, and that these streets be considered as priority one; and*
- b) *Retaining current standards with revised wording to provide clarity on priority 2 streets, (initial cut-through within 6 hours, after 10cm has fallen) with increased enforcement to ensure standards are being met. Plowing is to be repeated within 8 hours after initial pass. And, that improved focus on delivery to current service standards to be included when contracts are retendered after 2016/17.*

Amendments to Part 2

- a) *An increase in standard from 18 hrs to 12 hrs for Priority 2 sidewalks; and, increase standard from 36 hrs to 24 hrs for Priority 3 sidewalks. Also include a mechanism by which residents can clear their sidewalk to the Municipality's contractor-imposed standard before the contractors' arrival, and to require the contractor to lift the blade, so as to not obstruct an already cleared sidewalk.*
