# **RECOMMENDATION**

It is recommended that Halifax Regional Council adopt the recommendations of the Standing Committees and Community Council Appointments as outlined in Attachment # 1, to the report dated December 1, 2016.

#### **BACKGROUND/DISCUSSION**

Based on the terms of reference of the Standing Committees and Community Councils, as approved by Regional Council, each Committee and Council has the mandate to be the nominating/appointing body (to Regional Council) for the members of a number of Boards and Committees.

#### **Councillor Nominations**

Community Councils and Standing Committees of Council met in November & December, 2016 to review the expressions of interest put forward by members of Council serve on the following Boards and Committees:

- Canadian Urban Transportation Association (CUTA) (one Councillor nominated by and from the Transportation Standing Committee)
- **Grants Committee** (one member from each Community Council, the Chair to be nominated by and from the Audit and Finance Committee) \*
- Halifax Regional Water Commission (one Councillor nominated by and from the Environment & Sustainability Standing Committee and two Councillors at large nominated by the Environment & Sustainability Standing Committee)
- **Investment Policy Advisory Committee** (Co-Chair nominated by and from the Audit & Finance Standing Committee)

In accordance with AO1, the Environment & Sustainability and Transportation Standing Committee appointments were drawn from expressions of interest of Regional Council at large (except ESSC Water Commission representative and CUTA), and the appointments made by Audit and Finance were selected by and from their membership. The slate of appointees has been duly vetted and put forward by Community Councils and Standing Committees and is before Council for formal ratification.

\* Councillor Walker has been appointed as the Chair of the Grants Committee by the Audit & Finance Standing Committee and Halifax & West Community Council representative. This report recommends that Halifax & West Community Council appoint another member to the Grants Committee as their representative.

The final slate of Councillor appointments is targeted to be brought forward to Regional Council on January 24, 2017 and include the following committee/board appointments:
