SUBJECT: Council Meeting Schedule - Options

INFORMATION REPORT

ORIGIN

At the December 2005 Council meeting Councillor Younger requested a staff report on alternative council scheduling for 2007.

BACKGROUND / DISCUSSION

Administrative Order No.1 Section 8 (2) states that "Council shall meet every Tuesday by the hour of 6:00 p.m., with the exception of vacation periods as determined by Council by resolution". Each year in late fall the Municipal Clerk's Office circulates the proposed Regional Council meeting schedule for the upcoming year (current schedule attachment "A").

Based on Administrative Order No. 1, the schedule sets out weekly Council meetings to begin at 6:00 p.m. every Tuesday. The schedule also indicates dates for summer recess and for statutory holidays such as Victoria, Thanksgiving and the December holiday period. In addition, Committee of the Whole has been scheduled for the second and fourth Tuesday each month as required. Additional Committee of the Whole meetings are scheduled throughout the year as the need arises.

Staff seeks direction

To commence discussions on this topic draft attachment "B" indicates one option that Council may care to consider. Administrative Order No. 1 does not require Council to meet for Committee of the Whole on any specific day or time. It is possible to have Regional Council meetings (which would include Public Hearings) and In Camera meetings one week, alternating with Committee of the Whole the following week.

Under this scenario, motions passed at Committee of the Whole would be ratified by Regional Council immediately following the Committee of the Whole session. An amendment to Administrative Order No. 1 would be required to set out the process whereby Council would convene in order to ratify a recommendation from the Committee.

In terms of Community Council meeting dates, the option in draft attachment "B" could facilitate the Community Councils if they choose to meet on either the second or the fourth week of the month. This would mean that Community Councils could restrict their meetings to the same week as the Committee of the Whole meetings and this may provide more flexibility in their schedules during the weeks scheduled for Regional Council meetings.

In addition to the above suggested draft option, staff is requesting Council's direction regarding options that Members of Council would like to have considered in a revised meeting schedule format. Council may wish to refer discussion on this matter to a Council workshop session. Following input from Council, staff will return to Council with recommendations.

BUDGET IMPLICATIONS

There are no budget implications.
