





SUBJECT: **Provincial Road Transfer**

ORIGIN

September 27, 2005 Committee of the Whole Presentation

RECOMMENDATIONS

It is recommended that Regional Council:

1. endorse the Provincial Road Transfer in the Hammonds Plains area in accordance with the terms and conditions of Agreement HRM-01 as outlined in the attached correspondence dated September 26, 2005 from Hon. Ron S. Russell, Minister of Transportation and Public Works; and,
2. Approve the list of HRM owned roads (Appendix C) located outside the Urban Core Boundary, for conveyance to the Province in exchange for acceptance of Provincially owned roads located in the proposed exchange area which do not meet the density criteria thresholds under Agreement HRM-01(Appendix B) per the September 26, 2005 attachment.

BACKGROUND

At the September 27, 2005 Committee of the Whole, Council was briefed on the details of the road transfer in the Hammonds Plains/Stillwater Lake area in accordance with Agreement HRM-01, which will expand the Urban Core Boundary in the Hammonds Plains Road areas, from its present limit at Lucasville Road to Highway 103.

As noted in this presentation, there is an area of roads within the proposed Urban Core Boundary expansion area which does not meet the density criteria under the Agreement.

DISCUSSION

With reference to the attached correspondence from the Minister of NSTPW, Appendix A lists the 61.53 kms of Provincially owned roads in the subject area, scheduled for transfer to HRM under the terms and conditions of Agreement HRM-01, effective April 1, 2006. Clauses will be added to the annual winter service exchange agreement with NSTPW, to ensure continuity of winter snow & ice operations for the affected areas, regardless of the transfer date.

Appendix B of the Provincial correspondence lists the 9.27 of kms roads in the proposed Urban Core Boundary expansion area in the Pockwock area, which does not meet the density criteria of the Transfer Agreement. As indicated in the September 27, 2005 Committee of the Whole presentation, it is proposed to exchange an equivalent amount of HRM owned roads outside the Urban Core Boundary for the Appendix B list, under an operations rationalization process which facilitates road maintenance efficiencies to both the Province and HRM.

Appendix C as attached, lists 9.86 kms of HRM owned roads outside the Urban Core Boundary, proposed for exchange with the Province for the Pockwock area roads listed in Appendix B. Selection criteria for streets in Appendix C was based on locations where development densities would not trigger transfer thresholds for some time, as well as consideration for road maintenance efficiencies. It should also be noted that no gravel roads listed in Appendix C have been petitioned for paving by HRM.

BUDGET IMPLICATIONS

The transfer of roads as outlined will increase HRM's annual 2006/07 Operating Budget by an estimated \$750,000 and add an estimated \$3.5 million to HRM's outstanding capital gravel road paving obligations.

FINANCIAL MANAGEMENT POLICIES / BUSINESS PLAN

This report complies with the Municipality's Multi-Year Financial Strategy, the approved Operating, Capital and Reserve budgets, policies and procedures regarding withdrawals from the utilization of Capital and Operating reserves, as well as any relevant legislation.

ALTERNATIVES


The 61.53 kms of Provincial roads to be transferred to HRM is mandated under Agreement HRM-01. However, Council may choose to not proceed with the road exchange as proposed for areas not meeting the requirements of the agreement.



RE: Roads in Hammonds Plains Area of HRM

Further to your letter of April 12, 2005 and my response of May 17, 2005, I now give formal notice of my intention to transfer roads in the Hammonds Plains Area to Halifax Regional Municipality effective April 1, 2006.

I am advised that the area of Hammonds Plains shown on the attached map as "Area A" qualifies as an Urban Density Area as outlined in Agreement HRM-01. The associated provincial roads (61.53 km) are listed in the attached Appendix "A" and it is intended that they will be transferred in accordance with Agreement HRM-01.

I am further advised that our respective staffs have had discussions regarding a proposed transfer of an additional 9.27 km of roads in the Pockwock area that, while not meeting the criteria for an Urban Density area, should be transferred for reasons of operational efficiency. These roads are contained in the area shown as "Area B" on the attached map and the roads are listed in Appendix "B" attached. I understand that our staffs have reached agreement in principle to offset the 9.27 km in Area "B" by the Province assuming ownership and control of an equivalent length of HRM roads located outside the Core Area. The specific streets will be identified by HRM and reviewed by my staff before moving forward.

This is in keeping with our earlier exchange of correspondence and I am pleased that we have been able to move this matter forward in an expeditious manner.
