# **ORIGIN**

The Halifax Regional Municipality publically advertized tenders for Twelve(12) Model 2003 4-Door Sedan Patrol Cars for use within the Halifax Regional Police.

#### **RECOMMENDATION**

It is recommended that:

1. Council authorize the award of Tender #02-037 to Taylor Ford Lincoln at a price of \$27,818.41 (tax included) per unit for a total project cost of \$333,820.92 (tax included) with funding from Account CVK00287 as outlined in the Budget Implications section of this report.

Note: All prices include the non-refundable portion of the HST.

A total of ten(10) companies received tender documents with two (2) responding.
